Whereas, one of the many programs sponsored by the Indiana Bar Foundation is the Annual Indiana High School Mock Trial Competition, held on March 4-5, in Indianapolis, Indiana, included teams from high schools in northeast, northwest and central Indiana; and





AN ORDINANCE TO VACATE THE FOLLOWING DESCRIBED PROPERTY:

The portion of W. Monroe Street that lies approximately 179 feet west of S. Lafayette Blvd.

STATEMENT OF PURPOSE AND INTENT

Pursuant to Indiana Code Section 36-7-3-12, the Common Council is charged with the authority to hear all petitions to vacate public ways or public places within the City.



The Board of Public Works, at its January 24, 2017, meeting, reviewed the following comments by the Engineering Division, Area Plan Commission, Community Investment, Fire Department, Police Department, and the Solid Waste Division regarding the above request:

Area Plan stated, per IC 36-7-3-13, the vacation would not hinder the growth or orderly development of the unit or neighborhood in which it is located or to which it is contiguous. The vacation would not hinder the use of a public right of way by the neighborhood in which it is located or to which it is contiguous.

Engineering, Area Plan, and Community Investment stated the vacation would make access to the lands of the aggrieved person by means of public way difficult or inconvenient and the vacation would hinder the public's access to a church, school or other public building or place, both violations of Indiana Statute.

Therefore, the Board of Public Works submitted a favorable recommendation for the vacation of this street **subject to completion of a signed and recorded permanent access agreement** between the owner of the Zion Missionary Baptist Church, Inc. and the South Bend Cubs received prior to submittal of the application for vacation to the Common Council. A copy of the signed and recorded document shall be provided to the Board of Public Works.

The staff has reviewed this petition, and would note that in it's opinion, the ROW in question is a street and not an alley. It is further the staff's opinion that:

(1) The vacation would not hinder the growth or orderly development of the unit or neighborhood in which it is located or to which it is contiguous.

The general street pattern has been re-aligned, causing the continuation of Monroe west of Lafayette to no longer being needed for the redevelopment of the parcels adjacent to it.

- (2) The vacation would make access to the lands of the aggrieved person by means of public way difficult or inconvenient.
- The staff notes that the vacation of Monroe Street will effectively land-lock the parcel owned by Zion Missionary Baptist Church, Inc. Property owners should have a reasonable guarantee that they have access to a dedicated public right-of-way without having to rely on a private agreement.
- (3) The vacation would hinder the public's access to a church, school, or other public building or place.

The staff is not aware if the building that would potentially be landlocked is still used as a church. If so, this petition cannot meet Criteria #3.

(4) The vacation would not hinder the use of a public way by the neighborhood in which it is located or to which it is contiguous.

Monroe Street is already a dead-end street. Vacating the balance would not hinder its use.







Attached for the Common Council's consideration is an amendment to Chapter 2, Article 5, Section 2-52 of the South Bend Municipal Code. In fall of 2016, the Common Council created the City Department of Venues, Parks & Arts through both the budget approval process and a vote to amend Chapter 2, Article 4, Section 2-13. Among other duties, the Department of Venues, Parks & Arts is responsible for the Morris Performing Arts Center, Palais Royale and the Century Center.

Indiana Code 36-10-10 creates the Civic Center Board of Managers to oversee the Century Center and also grants this board the ability to have authority over "any other public facility owned or leased by the city or by an agency of it." The amendment before you extends general management authority of the Civic Center Board of Managers to include the facilities of the Morris Performing Arts Center and the Palais Royale.

This amendment is consistent with the Venues, Parks & Arts Department's expressed organizational goal to unite the Century Center, Morris Performing Arts Center and the Palais Royale under one management structure. This change has the broad support of the Civic Center Board of Managers as discussed at its public meeting on February 15, 2017 and empowers the body to change their by-laws accordingly.

AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF SOUTH BEND, INDIANA, AMENDING CHAPTER 2, ARTICLE 5, SECTION 2-52 OF THE SOUTH BEND MUNICIPAL CODE TO INCLUDE ADDITIONAL FACILITIES TO BE OPERATED, MAINTAINED AND MANAGED BY THE SOUTH BEND CIVIC CENTER BOARD OF MANAGERS

STATEMENT OF PURPOSE AND INTENT

Indiana law at Ind. Code § 36-10-10, and more particularly §36-10-10-29, specifically grants to the city of South Bend, Indiana, the authority to create a nine-member Board of managers to operate, maintain, and manage its civic center, which is known as the Century Center. That authority extends to "any other public facility owned or leased by the city or by an agency of it" IC §36-10-10-29(a) (2). Pursuant to that statute, the City of South Bend designated the South Bend Civic Center Board of Managers to manage, operate, and maintain "Century Center and its programs." (*South Bend Municipal Code*, Chapter 2, Article 5, Section 2-52). As identified at IC 36-10-2-5, city facilities include "neighborhood centers, community centers, civic centers, convention centers, auditoriums, arenas and stadiums." At this time the general management authority of the Civic Center Board of Managers should be expanded to include the facilities of the Morris Performing Arts Center and the Palais Royale.

As downtown South Bend continues to grow as an entertainment and convention center with increased hotel and tourist options, and with local population growth, and more restaurant/ entertainment facilities, the success of the City's Century Center, Morris Performing Arts Center, and Palais Royale become increasingly intertwined. Uniting these entities under one management board with the goal of maximizing overall benefit will improve the ability of each entity to thrive. This ordinance is a critical step toward that goal and is in the best interest of the City of South Bend and its citizens.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF SOUTH BEND, INDIANA, AS FOLLOWS:

<u>SECTION I.</u> Chapter 2, Article 5, Section 2-52 of the South Bend Municipal Code is amended to read in its entirety as follows:

The South Bend Civic Center Board of Managers, a board of managers for the purpose of supervising, managing, operating, and maintaining Century Center, the Morris Performing Arts Center, the Palais Royale and its- their programs, is hereby continued pursuant to IC 36-10-2-5.

<u>Section II.</u> This Ordinance shall be in full force and effect upon its passage by the Common Council and approval by the Mayor.



AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF SOUTH BEND, INDIANA, CORRECTING A SCRIVENER'S ERROR IN ORDINANCE NO. 9717-06 AS TO THE DESCRIPTION OF REAL PROPERTY FOR THE VACATION OF CERTAIN PARTS OF FRANCES STREET

STATEMENT OF PURPOSE AND INTENT

The purpose and intent of this ordinance is to correct a scrivener's error in Ordinance 9717-06 (vacating certain parts of Frances Street) which was adopted by this Council on November 29, 2006, a copy of which is attached for reference. Ordinance 9717-06 is otherwise reaffirmed in its entirety.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF SOUTH BEND, INDIANA, AS FOLLOWS:

SECTION I. The caption of Ordinance No. 9717-06 is amended to read in its entirety as follows:

AN ORDINANCE TO VACATE THE FOLLOWING DESCRIBED PROPERTY:

The street to be vacated is Frances Street from the North right of way line of Colfax Avenue to the first <u>East/West North/South</u> alley North of Colfax Avenue for a distance of 198 feet and a width of 66 feet. Additionally, an area 45 feet north of the south right of way of Luther Court and 23 feet west of the east right of way line of Frances Street. Being a part of the Original Town of Lowell, now City of South Bend, Portage Township, St. Joseph County, Indiana.

SECTION II. Section I of Ordinance Numbered 9717-06 shall be corrected to read in its entirety as follows:
