



AN ORDINANCE AMENDING THE ZONING ORDINANCE FOR PROPERTY LOCATED AT 131 CHAPIN STREEET, COUNCILMANIC DISTRICT NO. 2 IN THE CITY OF SOUTH BEND, INDIANA

STATEMENT OF PURPOSE AND INTENT

Petitioners desire to rezone the property from SF2 to O for a hotel.

NOW THEREFORE BE IT ORDAINED by the Common Council of the City of South Bend, Indiana as follows:

<u>SECTION I.</u> Ordinance No. 9495-04, is amended, which ordinance is commonly known as the Zoning Ordinance of the City of South Bend, Indiana, be and the same hereby is amended in order that the zoning classification of the following described real estate in the City of South Bend, St. Joseph County, State of Indiana:

A LOT OF PARCEL OF LAND FIFTY-TWO (52) FEET IN WIDTH FRONTING ON SOUTH CHAPIN STREET, AND BEING A PART OF LOT NUMBERED TEN (10) AS SHOWN ON THE PLAT OF ANN THOMAS' SUBDIVISION OF A PART OF BANK OUT LOT NUMBERED SEVENTY-FOUR (74) OF THE FIRST PLAT OF OUT LOTS OF THE TOWN, NOW CITY OF SOUTH BEND, PLATTED BY THE STATE BANK OF INDIANA, WHICH PART IS BOUNDED BY A LINE RUNNING AS FOLLOWS:





Requested Action:

The petitioner is requesting a zone change from SF2 Single Family & Two Family District to O Office District.

Land Uses and Zoning:

On site: On site is a single-family home and a two car garage.

- North: To the north are single-family homes zoned SF2 Single Family & Two Family District.
- East: To the east are single-family homes zoned SF2 Single Family & Two Family District.
- South: To the south is the Studebaker National Museum and the History Museum zoned O Office District.
- West: To the west is the Studebaker National Museum and the History Museum zoned O Office District.

District Uses and Development Standards:

The O - Office District is established to promote the development of: general office uses and complexes; professional health care uses and complexes; limited public and semipublic uses; and, other uses which are generally compatible in physical appearance and service requirements to office uses. The potential for the development of multifamily dwellings is also provided. The O District is intended for areas with easy access and high visibility from primary transportation routes.

Site Plan Description:

The site plan shows the single-family home being converted into a hotel with 6 guest rooms. Parking will be located in the two car garage and on-street. The proper landscaping is provided. Future development will need to meet the development standards of the O Office District.

Zoning and Land Use History And Trends:

The single-family homes have been zoned SF2 Single Family & Two Family District and the museums have been zoned O Office District since the adoption of the zoning ordinance in 2004.

Traffic and Transportation Considerations:

Chapin Street is two lanes with on-street parking.

Utilities:

The site will be served by municipal water and sewer.

Staff Report

Agency Comments:

The City Engineer offers a favorable recommendation. The Department of Community Investment offers an unfavorable recommendation. They stated that the neighborhood, with the support of the City, has successfully worked on a long-term revitalization strategy to preserve and enhance the historic residential character of the area. DCI suggested, if Council were to approve it, that commitments be made limiting the use to a hotel with 6 guest rooms, maintain the property's character, provide off-street parking at the rear of the property hidden from view from Chapin Street, and make any signage consistent with that found in residential areas.

Commitments:

The petitioner is proposing a written commitment to limit the use to a hotel with 6 guest rooms.

Criteria to be considered in reviewing rezoning requests, per IC 36-7-4-603:

1. Comprehensive Plan:

Policy Plan:

This petition is consistent with City Plan, South Bend Comprehensive Plan (2006), Objective ED 1: Stimulate the rehabilitation and adaptive reuse of property in the city; and Objective ED 9.1: Promote tourism opportunities in the city by actively highlighting the assets of South Bend.

Land Use Plan:

The Future Land Use Plan identifies this area for medium-density residential uses.

Plan Implementation/Other Plans:

The West-Washington-Chapin Development Area Plan identifies this site for residential development.

2. Current Conditions and Character:

The current conditions of the area are single-family uses and the institutional use of the museums.

3. Most Desirable Use:

The most desirable use for the property is one that preserves the character of the residential neighborhood.

4. Conservation of Property Values:

The site is adjacent to the History Museum zoned O Office District. With the proposed written commitments, the rezoning should not adversely affect adjacent property values.

5. Responsible Development And Growth:

It is responsible development and growth to allow the adaptive reuse of existing structures with conditions that fit it in the context of the neighborhood in which its locating.

Staff Comments:

The staff is requesting two written commitments: 1) to limit signage to a maximum of 16 square feet and, if illuminated, that only external illumination be utilized; and 2) the single-


family residential form and character of the building shall be maintained. Access to the guest rooms will occur internally through one primary entrance.


Recommendation:

Dear Council Members:

Under our current building permit ordinance, applicants are allowed to receive building permits even if they have past due building permit or inspection fees owing to the City. Fiscal responsibility requires these applicants to pay those past due fees prior to obtaining a new building permit.

More troubling, however, is the fact that applicants can receive building permits without any showing that the completed project will comply with applicable zoning ordinances. This is a classic example of putting the horse before the cart. The result is that the applicant often times must later apply for variances, special exception or zoning changes and risk that he receives an unfavorable recommendation and/or rejection by the Council. At best, even if those petitions are favorably acted upon, there is a waste of time and money in processing those petitions.

This amendment cures that problem. Under this amendment, an applicant must show that the completed project will comply with applicable zoning ordinances prior to obtaining a building permit.

Finally, this amendment "grandfathers" in building permits received prior to the effective date of the amended ordinance so long as certain conditions for completion are met. There will therefore be no prejudice to those who have acted under current law.

I request first reading at the July 8 Council meeting with second and third readings and public hearing at the July 22 meeting. I also ask for your support.

ORDINANCE NO.

AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF SOUTH BEND, INDIANA, AMENDING CHAPTER 6, ARTICLE 1, SECTION 6-4 OF THE SOUTH BEND MUNICIPAL CODE TO REQUIRE PAYMENT OF ALL PAST PERMIT AND INSPECTION FEES AND COMPLIANCE ALL APPLICABLE ZONING ORDINANCES PRIOR TO THE ISSUANCE OF A BUILDING PERMIT, EXCEPTING CERTAIN BUILDING PERMITS ISSUED IN ACCORDANCE WITH LAW PRIOR TO THE EFFECTIVE DATE OF THIS AMENDED ORDINANCE

STATEMENT OF PURPOSE AND INTENT

Under the current structure of the ordinance providing for the issue of building permits, a permit may be issued to persons or entities that have past due building and/or inspection fees owed to the City. Financial responsibility requires that any such past due amounts be paid in full prior to the issuance of a building permit. This amendment requires such payment.

The current ordinance also allows the issuance of a building permit with no showing that the proposed project will be in compliance with all applicable zoning ordinances. This leads to the possibility that construction may begin and be substantially completed with no assurance that the proposed project will be permitted under the zoning ordinances. This results in a waste of time and money by either requiring changes in the construction and use of the proposed project and/or the filing and consideration of petitions seeking exceptions from the applicable zoning ordinances or for zoning changes. This amendment requires a showing that the proposed project, when completed, will comply with all applicable zoning ordinances.

Finally, in order to not prejudice any entity that has been issued a building permit under the ordinance prior to it being amended, this ordinance "grandfathers" in building permits issued under current law so long as certain conditions for completion are met.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF SOUTH BEND, INDIANA, AS FOLLOWS:

SECTION I. Chapter 6 (Building), Article 1, Section 6-4 of the South Bend Municipal Code is hereby amended to read in its entirety as follows:

Sec. 6-4. Permit Fees

- (a) No person shall build or construct any new building or structure, or alter, repair, remodel, demolish, or move an existing structure, or install a sign, billboard, fence, inground pool, or wood burning stove within the City without obtaining, in advance, a permit from the Department.
- (b) Withhold issuance of permits.

- 1. Whenever a person who is either an applicant for a building permit or an obtainer of a building permit owes fees (including checks returned for insufficient funds, permit fees owed pursuant to the South Bend Municipal Code, or inspection fees owed pursuant to the South Bend Municipal Code) to the Building Department, the Building Commissioner shall withhold the issuance of subsequently requested permits until such time that the debt is satisfied.
- 2. Whenever a person applies for a building permit for a structure that is not being used or constructed in conformance with applicable provisions of an applicable zoning ordinance or other ordinance relating to land use, the Building Commissioner shall withhold the issuance of requested permits until such time that the property is brought into conformance with applicable ordinances.

(c) Permit revocation. The Building Commissioner may [shall] revoke a building permit when any of the following are applicable:

1. The application, plans or supporting documents contain a false statement or misrepresentation as to a material fact.

2. The application, plans or supporting documents reflect a lack of compliance with building standards and procedures.

3. There is failure to comply with the Building Ordinance.

4. The structure for which the building permit has been issued is not being used or constructed in

conformance with an applicable zoning ordinance or other ordinance relating to land use.

(d) Where a building permit for a building or structure has been issued in accordance with law prior to the effective date of the ordinance from which this section is derived, and provided that construction is begun within six months of the effective date and diligently prosecuted to completion, that building or structure may be completed in accordance with the approved plans on the basis of which the building permit has been issued, and further may, upon completion, be occupied under a certificate of occupancy by the use for which originally designated, subject thereafter, if applicable, to the provisions herein for nonconforming buildings, structures, and uses.

(e) Unless otherwise provided in the Building Code, the fees to be charged for the issuance of permits by the Department shall be paid at the time the permit is issued.

(1) The fee for permits issued for residential and commercial new construction and building additions shall be based upon the following:

a. Cost per Square Foot (CSF) times the total square footage (TSF) times the Local Variable Factor (LVF) of \$0.00098.

b. Cost per square foot (CSF) shall be determined by the International Code Council Building Valuation Table in effect in January of each year.

c. The cost per square foot (CSF) by occupancy classifications shall be amended as follows:

1. Groups F-1, F-2, H-1, H-2, H-3, H-4, and M shall have the same rate as A-3.

2. Groups I-4, R-2, and R-4 shall have the same rate as I-1.

3. Groups S-1, S-2, and U shall have the same rate as R-3.

d. Minimum fee-Forty dollars (\$40.00).

(2) Permits issued for all alterations, repairs, remodeling of existing structures over five hundred dollars (\$500.00), fence installations, in-ground pool installations, communication towers, and utilities shall be subject to the following fee schedule:

(7) Sign Permits. Fees shall be charged for the issuance of permits for the installation or erection of freestanding signs; billboards, including outdoor and off-premises signs; fascia signs; marquee or canopy signs and for lettering on buildings as follows:

a. Under one (1) square foot or less of display area and embellishments: No fee:

b. One (1) square foot to twenty-five (25) square feet of display area and embellishments: Forty dollars (\$40.00);

c. Twenty-six (26) square feet to fifty (50) square feet of display area and embellishments: Sixty dollars (\$60.00);

d. Fifty-one (51) square feet to one hundred (100) square feet of display area and embellishments: Eighty-five dollars (\$85.00);
e. In excess of one hundred (100) square feet of display area and embellishments: One hundred twenty dollars (\$120.00);
f. Temporary signs: Initial permit, Forty dollars (\$40.00); each extension of a temporary permit, Forty-five dollars (\$45.00).

(8) Wrecking and demolition permit fees shall be as follows:

a. Residential:

1. \$0.02 per square foot, with a minimum fee of Forty dollars (\$40.00).

b. Commercial:

1. \$0.015 per square foot, with a minimum fee of Forty dollars (\$40.00).

(9) Move any one- or two-story building over public streets or alleys: One hundred twenty-five dollars (\$125.00).

(10) Move any building greater than two (2) stories in height over public streets or alleys: One hundred seventy-five dollars (\$175.00).

(11) The fee for installation of a wood-burning stove shall be forty dollars (\$40.00) per flue (including chimney and chimney connector).

(f) The fees provided in this section shall not include permits for plumbing, heating or electrical installations covered by other provisions of this Code or other ordinances of the City.

(g) Refunds of fees paid for permits which have been revoked for any reason, or which have expired prior to full completion of work shall not be made; nor shall such fee be applied to reduce the fee of any subsequent permit issued by the Department, including any permit which may be issued for any structure at the same location.

(h) Where a person shall unlawfully proceed to do any work or construction without a required permit, the applicable permit fees shall be tripled as a penalty. The payment of such penalty shall not release the person in default from any other penalties hereafter provided, nor from compliance with any relevant provisions of the Building Code.

(i) The Building Commissioner shall periodically review the permit fees charged by the Department, comparing the fees to those charged by other local governmental entities and comparing the total annual fees collected to the annual cost of operating the Building Department. Such a review shall be made at least once every three (3) years. The Building Commissioner shall report the findings and conclusions from such review to the Common Council of the City.

SECTION II. <u>Severability</u>. If any provision of this Ordinance is found to be invalid, the remaining provisions of this Ordinance shall not be affected by such a determination. These other provisions of this Ordinance shall remain in full force and effect without the invalid provision.

SECTION III. Implementation Date.

The Building Commissioner shall apply this ordinance to all requests for building permits made after the date the amended ordinance becomes effective.

SECTION IV. This Ordinance shall be in full force and effect from and after the date of adoption by the City Council of the City of South Bend, St. Joseph County, Indiana.

As you know, the South Bend Municipal Code prohibits the use of many hand-held communication devices by drivers in school zones. Many studies, however, have determined that the problem with distracted driving, together with resultant property damage and personal injuries, is not limited to school zones, but exists on virtually every roadway.

This proposed ordinance repeals the current ordinance and, in its place, expands the regulations on the use of hand-held communication devices while driving on all roadways in South Bend. The proposed ordinance also creates very limited exceptions, primarily for police, fire and other first responders acting within the course and scope of their employment.

Distracted driving is a danger to everyone in the community, be it the distracted driver himself, other motorists using the roadway, pedestrians and all who are connected to anyone injured or killed. This proposed ordinance is a step in the right direction and within the jurisdiction of the Common Council to reduce distracted driving.

I am requesting that this proposed ordinance be given first reading at the Council meeting on July 22, 2019 with the public hearing and second and third readings at the following meeting.

AN ORDINANCE OF THE COMMON COUNCIL OF SOUTH BEND, INDIANA, AMENDING THE SOUTH BEND MUNICIPAL CODE BY REPEALING CURRENT CHAPTER 20, ARTICLE 13 AND THE INCLUSION OF NEW CHAPTER 20, ARTICLE 13, ENTITLED "REGULATIONS ON THE USE OF HAND-HELD MOBILE OR WIRELESS TELEPHONES, ELECTRONIC COMMUNICATIONS DEVICES AND TELECOMMUNICATIONS DEVICES WHILE DRIVING"

STATEMENT OF PURPOSE AND INTENT

The current version of Chapter 20, Article 13 of the South Bend Municipal Code prohibits the use of certain hand-held communication devices only in school zones. Subsequent data has made it clear that distracted driving through use of hand-held communication devices has increased accidents resulting in personal injuries and property damages on all types of roadways, not just in school zones. Indiana Code 9-21-1-2 provides local authorities, with the right to adopt, by ordinance, traffic regulations with respect to highways under the local authority's jurisdiction, as long as the ordinance does not conflict with, or duplicate, a statute. This ordinance does not conflict with or duplicate a statute and is designed to reduce the number of motor vehicle accidents caused by distracted driving by expanding the prohibition on the use of hand-held communication devices while driving on any roadway within the City of South Bend.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF SOUTH BEND, INDIANA, as follows: Section I. Chapter 20, Article 13 is hereby amended to read in its entirety as follows:

ARTICLE 13.- REGULATIONS ON THE USE OF HAND-HELD MOBILE OR WIRELESS TELEPHONES, ELECTRONIC COMMUNICATIONS DEVICES ANDTELECOMMUNICATIONS DEVICES WHILE DRIVING

Sec. 20-130. - Definitions.

In this article:

- (1) *Electronic communications device*, except as provided in subsection (h), means any of the following:
 - (a) A broadband personal communications device.
 - (b) A gaming system or device capable of displaying games.
 - (c) A handheld device, laptop computer, or tablet computer

with mobile data access.

(d) A pager or two-way messaging device.

(e) A personal digital assistant.

(f) A mobile or wireless telephone.

(g) The functional equivalent or successor to any device listed

in subdivisions (a) through (f).

(h) The term does not include the following:

(1) Amateur radio equipment that is being operated by a person licensed as an amateur radio operator by the Federal Communications Commission under 47 CFR Part 97.

(2) A communications system installed in a commercial motor vehicle weighing more than ten thousand (10,000) pounds.

- (2) *Engaging in a call* means talking into, dialing or listening on a hand-held mobile or wireless telephone, but does not include holding a mobile telephone to activate or deactivate the telephone by pressing not more than one (1) button to initiate or terminate a voice communication or other transmission described in this article.
- (3) *Hand-held mobile telephone* means a mobile or wireless telephone with which a user engages in a call using at least one hand (or prosthetic device or aid in the case of a physically disabled person).
- (4) *Hands-free mobile telephone* means a mobile or wireless telephone that has an internal feature or function or that is equipped with an attachment or addition, whether or not permanently part of the mobile or wireless telephone, by which a user engages in a call without the use of either hand (or prosthetic device or aid in the case of a physically disabled person) whether or not the use of either hand (or prosthetic device) is necessary to activate or deactivate the mobile telephone.
- (5) *Mobile communication device* means a text-messaging device or other electronic, twoway communication device that is designed to receive and transmit voice communication, text communication, or both. The term includes a mobile telephone and a personal digital assistant (PDA).
- (6) *Mobile telephone* means a device used by subscribers and other users of wireless telephone service to access such service.
- (7) School crossing zone means a part of a roadway distinctly indicated for crossing by children on the way to or from school by lines or other markings on the surface of the roadway or by signs as addressed by Indiana Code §9-13-2-161.5.
- (8) Text message means a two-way communication (whether real-time or asynchronous) in which data (composed in whole or in part of text, numbers, images or symbols) is sent, entered or received by a method other than by voice and transmitted through either a short message service (SMS) or a computer network. The term includes electronic or e-mails. The term does not include a communication transmitted through a global positioning or navigation system.

- (9) *Telecommunications device* means an electronic or digital telecommunications device or digital telecommunications device as addressed in Indiana Code §9-13-2-177.3 and includes hand-held mobile or wireless telephones and mobile communication devices.
- (10) *Wireless telephone* means a device used by subscribers and other users of wireless telephone service to access such service.
- (11) *Wireless telephone service* means two-way, real time voice telecommunications service that is interconnected to a public switched telephone network and is commonly referred to as cellular service or personal communication service.

Sec. 20-131. - Drivers prohibited from using hand-held mobile or wireless telephones, mobile communication devices and telecommunication devices while driving.

(1) Except as provided in Sec. 20-132, a person may not:

(a) hold or handle an electronic communications device;

- (b) participate in text messaging; or
- (c) view, record, or broadcast images or video;

while operating a moving motor vehicle.

(2) An operator of a motor vehicle who holds a mobile telephone or telecommunications device or an electronic communications device to or in the immediate proximity of his or her ear while the vehicle is in motion is presumed to be engaging in a call under this article. Immediate proximity is any distance that permits the user of a mobile telephone or telecommunication device to hear telecommunications transmitted over the telephone or device and does not require physical contact with the user's ear.

Sec. 20-132. - Limited exceptions.

Section 20-131 does not apply to the following:

- (1) A law enforcement officer who is operating within the scope of the officer's employment, including while the law enforcement officer is:
 - (A) working in a plainclothes capacity;
 - (B) working in an undercover capacity; or
 - (C) responding to an emergency.

(2) A firefighter, emergency medical technician (EMT), paramedic, other first responder or other emergency personnel while acting within the scope of their employment and while responding to an emergency.

(3) A driver using an electronic communications device for the sole purpose of communicating with emergency personnel or law enforcement regarding an emergency.

(4) A driver using an electronic communications device by means of hands free or voice operated technology, including by:

(A) use of a headset or earpiece to conduct a voice communication;

(B) use of a device that is:

(i) designed to be worn on the wrist; and

(ii) capable of being used to conduct hands free voice communication;

(C) use of technology that uses voice recognition to convert a voice communication into text for purposes of transmission as a text message, electronic mail message, or other electronic data; if the device requires the driver to press not more than one (1) button to initiate or terminate a voice communication or transmission described in this subdivision.

(4) A driver using an electronic communications device while parked on the shoulder of a public highway.

(5) A driver using an electronic communications device when:

(A) the vehicle is not in motion; and

(B) the vehicle's transmission is in "park".

(6) A driver using:

(A) a navigation or global positioning feature of an electronic communications device; or

(B) a fixed device that is designed to continuously record or broadcast video from within or outside a motor vehicle; without holding or handling the device.

(7) A driver using a manufacturer installed system that is embedded or integrated into the vehicle.

Sec. 20-133. - Violations and penalties.

(1) Any person violating any provisions of this article shall be issued a citation and be subject to the following fines:

- (a) Seventy-five dollars (\$75.00) for the first violation;
- (b) One hundred twenty-five dollars (\$125.00) for the second violation;
- (c) Two hundred fifty dollars (\$250.00) for all subsequent violations.

However, if a person is violating any provisions of this article in a school crossing zone, the citation shall automatically result in a fine of two hundred fifty dollars (\$250.00).

- (2) Any person issued a citation for violating any provision of this article shall make payment through the Ordinance Violations Bureau. Failure to make payment within thirty (30) days of the issuance of the citation shall result in the assessment of a late fee of fifty dollars (\$50.00).
- (3) Each violation of this article shall constitute a separate offense.

Sec. 20-134. - Deposit of fine monies into Police Department Training Fund.

- (1) All monies collected and retained by the City for violation of this article shall be deposited into the Police Department Training Fund (Fund #220). Such monies shall be used solely for the purposes designated for such fund. All interest earned on the monies deposited in Fund #220 shall not revert to the General Fund.
- (2) The Department of Administration and Finance shall send monthly written reports to the Office of the City Clerk detailing the amount of money collected and the amount of interest earned, with such reporting being filed no later than the last business day of each month.

President Scott,

I am respectfully requesting the South Bend Common Council consider my recommendation to increase the Ambulance User Fees charged by the South Bend Fire Department. As required by The South Bend Municipal Code, Chapter 9, Article 3, Section 9-18, I have provided the required 2019 Annual Review of User Fees with the recommendation for an increase that reflects the increase in reimbursement amounts allowed by Medicare. These amounts are current to this year. As I have stated in the past, Medicare typically adjusts this reimbursement allowance at least annually, which usually includes an increase in the rate of reimbursement. If adjustments are not made to our user fees periodically, we are unable to take advantage of Medicare's reimbursement increases.

This ordinance also includes a provision for self-effectuating annual fee increases based on Medicare or similar federal or state annual rate adjustments. I recommend adoption of this selfeffectuating provision because Medicare and similar rates provide a reliable, pre-approved standard for reasonableness and relationship of cost to service. Additionally, there is a provision to recover fees for services provided by a paramedic intercept vehicle. The SBFD recently put into service a paramedic intercept concept by which a lead paramedic is called to provide advanced life support services to the most critical patients.

I appreciate your consideration in this matter. I look forward to presenting the ordinance to Council at your committee and regular meetings.

STATEMENT OF PURPOSE AND INTENT

Since 1981, the City of South Bend, Indiana has codified the regulation of ambulance and medical user fees into the *South Bend Municipal Code*. South Bend's current ambulance and medical user fees took effect on June 27, 2016 (Ordinance No. 10444-16).

The South Bend Fire Administration has regularly reported to the Common Council its ambulance service activity pursuant to Chapter 9, Section 9-18 of the *South Bend Municipal Code*, and has provided its recommendation regarding adjustment of user fees. The Fire Chief's most recent report was submitted to the South Bend Common Council on May 31, 2019.

The City's ambulance and medical user fees have remained unchanged for over three years but based on its recent survey of these fees and charges, and due to increased costs to the City for personnel training and necessary medical supplies, it is recommended that ambulance and medical user fees be adjusted consistent with the 2019 Medicare Fee Schedule. To help recover the costs and expenses of the Fire Department paramedic branch in providing ambulance and emergency medical services, an adjustment is required of the current rates.

It is also necessary to add and define a new category of ambulance and medical user fee for "paramedic intercept" services which are now reimbursed by Medicare. Such services are provided when paramedic support is rendered to an advanced life support non-paramedic ambulance in order to give a higher level of service to a patient in need of paramedic care.

It is further recommended by the Fire Administration that hereafter the South Bend Fire Chief be authorized to adjust these user fees once annually and automatically by the same percentage rate as any adjustments made to the Medicare Fee Schedule rates, with notice to the City Clerk after which such new rates will take effect. These changes are reasonable, appropriate, based on the cost of service as reasonably determined by Medicare, and in the best interests of the City of South Bend.

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of South Bend, Indiana, as follows:

Section I. Chapter 9, Article 3, Section 9-16 of the *South Bend Municipal Code* shall be amended to read in its entirety as follows:

Sec. 9-16. Ambulance/medical user fee--Established.

(a) The following user fee schedule shall be charged for all ambulance/medical services provided by the City through its paramedic branch of the Fire Department:

- (b) The above fees shall be charged per patient run occurrence; however, when ambulance/medical services are provided for a patient using a private ambulance, the mileage fee shall not be charged; and further provided that when more than two (2) members of an immediate family residing at the same address are transported per incident, the basic fee, mileage fee, and emergency fee shall only be billed for two (2) persons.
- (c) Non-resident: Is defined as a person whose primary residence at the time of the service is outside the corporate boundaries of the City of South Bend, Indiana.
- (d) Basic Life Support (BLS): Means transportation by ground ambulance vehicle and medically necessary supplies and services, plus the provision of BLS ambulance services. The ambulance must be staffed by an individual who is qualified in accordance with State and local laws as an Emergency Medical Technician (EMT)¹.

¹ ALS1, ALS2 and BLS definitions track the language codified in Title 42 of the Code of Federal Regulations, Chapter IV, §414.605 entitled "Fee Schedule for Ambulance Services".

- (e) Advanced Life Support, Level 1 (ALS1): Means transportation by ground ambulance vehicles, medically necessary supplies and services and either an ALS assessment by ALS personnel or the provision of at least one ALS intervention.
- (f) Advance Life Support, Level 2 (ALS2): Means either transportation by ground ambulance vehicle, medically necessary supplies and services, and the administration of at least three (3) medications by intravenous pus/bolus or by continuous infusion excluding crystalloid, hypotonic, isotonic, and hypertonic solutions (Dextrose, Normal Saline, Ringer's Lactate); or transportation, medically necessary supplies and services, and the provision of at least one (1) of the following:
 - (1) Manual defibrillation/cardioversion
 - (2) Endotracheal intubation
 - (3) Central venous line
 - (4) Cardiac pacing
 - (5) Chest decompression
 - (6) Surgical airway
 - (7) Intraosseous line
- (g) Non-Transport Medical Calls: Means a response to a medical emergency call by ambulance vehicle and the administration of ALS skills upon or medication given to a patient who then refuses transport to the hospital.
- (h) <u>Paramedic Intercept Services: Means the rendering of lead paramedic advanced life support</u> (ALS) services, Level 1 or Level 2 during ambulance transport when the patient needs lead paramedic ALS service that the transporting ambulance is unable to provide. The lead paramedic is dispatched to meet the transport ambulance to provide the necessary lead paramedic - services.
- (h) (i) Mileage, Rural, shall apply to vehicle runs made to areas in zones or zip codes designated as rural by Medicare and the U.S. Department of Health and Human Services in its Medicare regulations.
 - (i) The above fees shall take effect on August 1, 2016 September 1, 2019.
 - (k) Hereafter, and in the event Medicare or other federal or State health care regulations require or allow an adjustment to ambulance/ medical user fees, the South Bend Fire Chief is authorized to and may amend once annually the user fees set out in subpart (a) of this Section by the same percentage as the Medicare Fee Schedule rates for such services have been adjusted. This adjustment shall be effective on the calendar date immediately following the date on which written notice of said fee rate adjustment is filed in the office of the City Clerk. At the time such notice is filed, a copy of the new rates shall be made available in paper form for public viewing in the South Bend Central Fire Station, and such new rates shall also be published promptly on the City's web site.

<u>Section II</u>. This ordinance shall be in full force and effect from and after its passage by the Common Council, approval by the Mayor, and any publication required by law, or by September 1, 2019, whichever is later.

AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF SOUTH BEND, INDIANA, AMENDING CHAPTER 2, ARTICLE 1, OF THE SOUTH BEND MUNICIPAL CODE OF BY THE INCLUSION OF NEW DIVISION I ENTITLED YOUTH ADVISORY COUNCIL

STATEMENT OF PURPOSE AND INTENT

On April 14, 2003 the South Bend Common Council passed Ordinance No. 9414-03 which created the Youth Advisory Council. That ordinance has been codified as Division 1 of Article 1 of Chapter 2 of the *South Bend Municipal Code*. The ordinance created a mechanism for youth to provide input and become involved in the civic process so both youth and the city can benefit. It also provides opportunities for close engagement between Common Council Members, members of the City Administration, City agencies, boards, and commissions.

Strong neighborhood organizations are the building blocks of our local democracy. One strategy for creating healthier neighborhoods is "community organizing to motivate action, bringing people together to work collectively to improve neighborhoods." While there are individuals who demonstrate passion for improving the quality of life in their neighborhoods, many do not have the skills to effectively organize, lead, and sustain momentum to catalyze change.

The NRC and the City have committed to collaborating to ensure we are rebuilding the base of our local democracy through civic leadership education. Resident capacity to organize and communicate effectively with their government is critical to ensuring inclusive, representative civic voice. There are many issues in city government, in the South Bend community, and in its many neighborhoods that may be of interest to youth; such topics may include, but are not limited to, violence, educational and recreational opportunities, employment, homelessness, and climate change.

The Youth Advisory Council would provide a means for youth to positively connect with city government, explore local social justice and policy issues, and think critically about their role in potential policy and community development solutions through exploration of the arts and community-based research pedagogies developed in partnership by the NRC and the University of Notre Dame through their longstanding Engaging Youth, Engaging Neighborhoods program.

City government can directly benefit from the input of the youth in our community by developing a concept of positive youth involvement and providing an educational partnership with schools and other youth serving community-based organizations in the City of South Bend, Indiana.

The following regulations are believed to enhance and improve the overall operations and sustainability of the City of South Bend's Youth Advisory Council through collaboration with the NRC. This ordinance is aimed at streamlining many of the provisions of the current ordinance so that the Council can be more effective.

NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF SOUTH BEND, INDIANA AS FOLLOWS:

<u>Section I</u>. The Common Council of the City of South Bend, Indiana, hereby amends Chapter 2, Article 1 of the *Municipal Code of South Bend* by the inclusion of the new Division I which shall read in its entirety as follows:

DIVISION I. YOUTH ADVISORY COUNCIL.

Section II.

SEC. 2-12.1.1 YOUTH ADVISORY COUNCIL CREATED- PURPOSE.

(a) A Youth Advisory Council is created for those of high school age grades 10-12. A Youth Advisory Council is established to enhance citizenship skills and to serve the best interests of youth in the City of South Bend, Indiana.

(b) A Junior Youth Advisory Council, under the supervision of the Youth Advisory Council, to foster citizenship skills of youth of intermediate center age. The Youth Advisory Council would be required to prepare and file proper legislation for Common Council consideration, when it has determined that the Junior Youth Advisory Council should be created. Such Junior Youth Advisory Council would be representative of all public and private intermediate centers operating within the City of South Bend, Indiana.

SEC. 2-12.1.2 MEMBERSHIP OF THE YOUTH ADVISORY COUNCIL.

The Youth Advisory Council shall be composed of eleven (11) to twenty (20) new members per cohort. Membership shall represent the rich diversity of the city's youth regarding gender, race, ethnic, socio-economic, and religious backgrounds. Youth Council Advisory Council Members shall include:

- (a) At least one (1) Youth Member shall be appointed to represent each of the six (6) Councilmanic Districts.
- (b) Upon passage of this ordinance, the Office of the City Clerk shall see that the "Application Form" for the Youth Advisory Council is able to be downloaded from the city website and shall also provide to each Council Member and make

available to the public the Mayor, and each High School Principal, Youth Advisory Council application forms which shall be completed by youth interested for consideration on the Youth Advisory Council. The Office of the City Clerk shall see that information on the activities of the Youth Advisory Council are kept updated on the City's internet website. Hard-copy application forms shall be available and kept on file in the Office of the City Clerk during regular business hours. Additionally, applications forms shall be made available on the City's website http://www.southbendin.gov on a 24/7 basis.

- (1) All youth interested in consideration shall obtain and complete in its entirety an application form and file it, along with two (2) written references from non-related adults, with the Office of the City Clerk.
- (2) The Office of the City Clerk, by the application deadline, shall assimilate all information and timely distribute copies of all applications and references to the appropriate offices for consideration.
- (3) Each District Common Council Member shall review all applications received from the Office of the City Clerk requesting consideration for appointment as the District Youth Council Member. All youth interested in representing a Councilmanic District must be a resident of the City of South Bend, Indiana.
- (4) The Community Relations Committee Chair shall appoint an application review board comprised of Common Council, City Clerk, City administration, and NRC representative(s) and Youth Advisory Council Alumni members, Application Review Board members shall review all applications received from the Office of the City Clerk requesting consideration for appointment as a Youth Advisory Council Member. All youth interested in serving as a Youth Advisory Council member must be a resident of the City of South Bend and must represent the rich diversity of the community.
- (5) All Youth Advisory Council applications must be submitted by the end of September each year.
- (6) Council's Community Relations Committee shall appoint youth mentors of college and/or graduate school age who will provide assistance and guidance throughout the year to the Youth Advisory Council Members. The youth mentors shall interface with the legislative, administrative and educational liaisons identified in Sec. 2-12.1.5.

SEC. 2-12.1.3 OFFICERS AND TERMS OF OFFICE OF THE YOUTH ADVISORY COUNCIL.

(a) The Youth Advisory Council shall call an organizational meeting to select a Chairperson, Vice-Chairperson and Recording Secretary.

(b) The selected recording secretary, shall provide a listing of all Youth Advisory Council members by name, address, telephone number, email address, school, and year of education shall be submitted to the Office of the City Clerk by email for distribution to the Common Council, the city administration, School Superintendents and the Principal of each high school., the Neighborhood Resources Connection.

(c) Terms of office of Youth Advisory Council members shall be for one (1) year, with reappointments of the same youth member permitted for one (1) additional year.

(d) The Youth Advisory Council shall maintain a record of their meetings. Such meeting minutes shall be submitted to the Office of the City Clerk by email by the elected recording secretary.

SEC. 2-12.1.4 DUTIES OF YOUTH ADVISORY COUNCIL MEMBERS.

(a) Each Youth Advisory Council Member shall be required to attend meetings of the Youth Advisory Council, with three (3) excused absence permitted each year.

(b) Each Youth Advisory Council Member shall be required to attend not less than two (2) committee meetings of any Standing Committee of the South Bend Common Council, one (1) neighborhood association meeting, and one (1) school board meeting by the end of December of each year.

(c) Each Youth Advisory Council Member shall be required to attend the 2nd Common Council meeting in January where the Mayor presents his or her annual State of the City Address.

(d) Each Youth Advisory Council Member shall participate in the annual "Civic Day" activities occurring in February at the County-City Building, and other planned social or political action events.

(e) The Youth Advisory Council may monitor other city boards and commissions for issues related to youth and make recommendations for such boards or

commissions consideration when deemed appropriate.

SEC. 2-12. 1.5 INITIATIVES, RESPONSIBILITIES AND GOALS TO BE ADDRESSED BY MEMBERS.

- (a) The Youth Advisory Council may develop:
 - (a) Mission Statement;
 - (b) Committee structure if deemed necessary;
 - (c) Composite of the youth in the high school or district he or she is representing;
 - (d) Newsletters and other means of community with youth in the city;
 - (e) Grant proposals;
 - (f) Initiatives and Goals to be addressed, including but not limited to:
 - a. Leadership opportunities;
 - b. Civic responsibilities;
 - c. Arts & Activism;
 - d. Educational opportunities;
 - e. Youth perspectives on local issues;
 - f. Creating a means of formal communication between city officials and youth in our community;
 - g. Creating a model for youth involvement; and
 - h. Partnering with local, state, federal, and international organizations which focus on youth involvement and development.
 - i. Indicators of measuring success.
 - (b) The Youth Advisory Council shall make recommendations to enhance participation of youth throughout the community, to improve communications with school and governmental entities, and to improve employment opportunities for youth in the community.
 - (c) The Youth Advisory Council shall provide an annual report of its activities, initiatives and objectives.

(d) At the first Common Council meeting of each year, the Youth Advisory Council shall address the Common Council under the "Special Business" portion to provide an annual report of its activities, initiatives and objectives.

SEC. 2-12.1.6 LIAISONS TO THE YOUTH ADVISORY COUNCIL.

- (a) The Chairperson of the Common Council's Community Relations Committee shall be the legislative liaison to the Youth Advisory Council and be available for mentoring duties.
- (b) The City Administration shall designate a point of contact as a liaison to the Youth Advisory Council and be available for mentoring duties.
- (c) The Neighborhood Resources Corporation shall designate a point a contact as a program coordinator to the Youth Advisory Council to be responsible for coordinating programming duties.

<u>Section III</u>. This ordinance shall be in full force and effect from and after its passage by the Common Council, approval by the Mayor and media publication.







In order to permit a child care center.

SECTION II. Following a presentation by the Petitioner, and after proper public hearing, the Common Council hereby approves the petition of the Area Board of Zoning Appeals, a copy of which is on file in the Office of the City Clerk.

SECTION III. The Common Council of the City of South Bend, Indiana, hereby finds that:

- 1. The proposed use will not be injurious to the public health, safety, comfort, community moral standards, convenience or general welfare;
- 2. The proposed use will not injure or adversely affect the use of the adjacent area of property values therein;

- 3. The proposed use will be consistent with the character of the district in which it is located and the land uses authorized therein;
- 4. The proposed use is compatible with the recommendations of the City of South Bend Comprehensive plan;

SECTION IV. Approval is subject to the Petitioner complying with the reasonable conditions established by the Area Board of Zoning Appeals which are on file in the office of the City Clerk.

SECTION V. The Resolution shall be in full force and effect from and after its adoption by the Common Council and approval by the Mayor.
