Re: Amendment to City's Sick and Vacation Municipal Code Provisions

Dear Council President Scott:

The South Bend Municipal Code currently contains two provisions governing sick leave and vacation for City non-bargaining and Teamster employees. The substance of these provisions is also contained in the City's Vacation policy at page 35 of the Employee Handbook and the Sick Leave policy at page 38 of the Employee Handbook. The Handbook is distributed to every employee and is readily available on the City's intranet, in Human Resources, and in the Clerk's office. Employees and administration rely heavily on these policies in implementing the City's vacation and sick leave programs.

Recently, Human Resources has taken steps to revise the City's Vacation policy to provide vacation to new hires, improve equity across employee groups, and modify terms related to payout of vacation upon separation. In evaluating these revisions, Chapter 2, Article 8, Sections 2-119 (regarding sick leave) and 2-120 (related to vacation) of the Municipal Code provisions came to light. To improve clarity and avoid possible confusion, Human Resources is proposing consolidating these two Code provisions and incorporating by reference the City's Employee Handbook which contains the relevant policies and is readily available for inspection by employees and the public. This proposal, along with a proposed revision to the City's vacation policy, has been discussed and distributed to members of the Council's Personnel and Finance Committee. We are now pleased to present it to the full Council for consideration.

I will present this ordinance to the Council for committee hearing and for second and third Council reading. An attorney from the City Legal Department may also be present.

AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF SOUTH BEND, INDIANA, AMENDING CHAPTER 2, ARTICLE 8, SECTIONS 2-119 AND 2-220 OF THE SOUTH BEND MUNICPAL CODE, TO ADDRESS SICK LEAVE AND VACATIONS FOR OFFICERS AND EMPLOYEES

#### STATEMENT OF PURPOSE AND INTENT

The current version of the South Bend Municipal Code at Chapter 2, Article 8 contains specific provisions for City personnel regarding sick leave at Section 2-119, and for annual vacations at Section 2-219. Sick leave and annual vacations of City employee and officers are further described in greater detail within the City's Personnel Policies and Procedures manual which is available for public review on the City's website, and in the offices of the City Clerk and the City Department of Administration and Finance.

For better clarity and to reduce any confusion, it is preferable that details of personnel policies concerning sick leave and annual vacations be contained solely within the City's Personnel Policies and Procedures manual.

It is in the best interest of the City of South Bend to amend the South Bend Municipal Code for the above stated reasons.

**NOW, THEREFORE, BE IT ORDAINED** by the Common Council of the City of South Bend, Indiana as follows:

<u>SECTION I.</u> Chapter 2 Article 8, Section 2-119. Sick leave for all officers and employees shall be deleted in its entirety.

**SECTION II.** Chapter 2, Article 8, Section 2-120 shall be recodified as Section 2-119 and shall be amended to read in its entirety as follows:

## Sec. 2-12019. Sick Leave and Annual vacations for officers and employees.

(a) All officers and employees of the City shall be subject to the sick leave and the vacation schedules set forth in the City's Personnel Policies and Procedures as it may be amended from time to time which shall be available for public inspection in the office of the City Clerk and the office of the City Administration and Finance Department, and further as such schedules may be

amended in the annual salary ordinances enacted by the Common Council. The annual vacation privileges of officers and employees of the City whose anniversary date falls on or before December 31, 1986 shall be preserved.

- (b) "Years of service" means uninterrupted employment with the City. All references to years indicate a complete year of employment upon the employee's anniversary date rather than fiscal years.
- (c) Vacation time is not cumulative, and any days of vacation not actually used during the calendar year in which they accrue shall be lost with no additional compensation paid to employees not using those lost vacation days, subject to the City's Personnel Policies and Procedures which may allow use during the first quarter of the calendar year following the year in which the vacation days accrue.
- (bd) This section shall not apply to sworn police officers and firefighters.
- (ce) The Mayor at his or her discretion may alter the vacation schedule for heads of City Departments or for key employees having specialized expertise.

Sec. 2-125.1 125. Whistleblower protection.

Sec. 2-125.2. 125.1 Sexual H-harassment T-training and P-prevention Aawareness and P prevention T-training for City of South Bend E-elected O-officials and E employees.

**SECTION IV.** This ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.



The City is governed by the current zoning ordinance which went in to effect May 7, 2004 and which has been updated numerous times to respond to changing development practices. The Department of Community Investment, on behalf of the City, is actively working to reformat and revise the South Bend Zoning Ordinance with the intent that the new ordinance will take effect on January 1, 2020.

As part of the revisions of the South Bend Zoning Ordinance, and to streamline the process and aid in property development, this Ordinance confirms and approves the formation of the City of South Bend Advisory Plan Commission and Advisory Board of Zoning Appeals under Ind. Code 36-7-4, et seq. It further provides for the City's withdrawal from the St. Joseph County Area Plan Commission, which pursuant to Ind. Code 36-7-4-204, is permissible upon the municipality passing an ordinance to that effect.

This ordinance also amends the South Bend Municipal Code to reflect these changes, all of which is in the best interest of the City of South Bend, Indiana, the concept of which was approved by the South Bend Common Council in its Resolution No. 4769-19 passed unanimously on March 11, 2019.

I request first reading at the August 26 Council meeting with second and third readings and public hearing at the September 9 meeting. I also ask for your support.

ARTICLE 5

#### STATEMENT OF PURPOSE AND INTENT

On February 13, 1922, the City of South Bend, Indiana (the City) approved Ordinance No. 2233 establishing a "City Plan Commission" consisting of nine members as provided by the Acts of the General Assembly of the State of Indiana at its Regular Session of 1921. On September 28, 1964, the City passed Ordinance No. 4691-64 which adopted the provisions of the Area Planning Act of 1957 and resulted in the City joining the Area Plan Commission effective on January 1, 1965. As a member of the Area Plan Commission, the South Bend Common Council passed Ordinance No. 9917-09 on April 28, 2009, allowing the City to join the Area Board of Zoning Appeals, effective May 22, 2009. At this time, the Area Plan Commission of St. Joseph County continues to administer the zoning ordinance and development review procedures for the City.

The City is governed by the current zoning ordinance which went in to effect May 7, 2004 and which has been updated numerous times to respond to changing development practices. The Department of Community Investment, on behalf of the City, is actively working to reformat and revise the South Bend Zoning Ordinance with the intent that the new ordinance will take effect on January 1, 2020. As part of the revisions of the South Bend Zoning Ordinance, and to streamline the process and aid in property development, this Ordinance confirms and approves the formation of the City of South Bend Advisory Plan Commission and Advisory Board of Zoning Appeals under Ind. Code 36-7-4, et seq. It further provides for the City's withdrawal from the St. Joseph County Area Plan Commission, which pursuant to Ind. Code 36-7-4-204, is permissible upon the municipality passing an ordinance to that effect. (See 1977 Ind. Op. Atty. Gen. 64 interpreting the former version of that statute.) This ordinance also amends the South Bend Municipal Code to reflect these changes, all of which is in the best interest of the City of South Bend, Indiana, the concept of which was approved by the South Bend Common Council in its Resolution No. 4769-19 passed unanimously on March 11, 2019.

**NOW, THEREFORE, BE IT ORDAINED** by the Common Council of the City of South Bend, Indiana, as follows:

**SECTION I.** The Common Council hereby affirms its intent to form and support the City of South Bend Advisory Plan Commission and Advisory Board of Zoning Appeals as provided in IC 36-7-4, et seq. each of which Commission and Board shall become operative on December 1, 2019.

**SECTION II.** In conjunction with formation of the South Bend Advisory Plan Commission and the Advisory Board of Zoning Appeals under Section I of this ordinance, the City of South Bend by December 31, 2019 and upon due appointment by law of all members of each body, shall be deemed to have withdrawn respectively from the St. Joseph County Area Plan Commission and the St. Joseph County Area Board of Zoning Appeals, and will promptly, formally send notice of such withdrawal to each St. Joseph County entity.

SECTION III. The South Bend Advisory Plan Commission and South Bend Advisory Board of Zoning Appeals shall have jurisdiction as of January 1, 2020 over all matters within the current edition of the South Bend Zoning Ordinance, and within the revised South Bend Zoning Ordinance upon that ordinance's effective date. Should any zoning application be pending before the St. Joseph County Area Plan Commission or the St. Joseph County Board of Zoning Appeals at the time of the revised zoning ordinance's effective date, either Board may require the affected property owner to withdraw the original application and to reapply for consideration under the revised Zoning ordinance, or to amend the original application under the contents of the new zoning ordinance. Any such new application shall be at no additional cost to the applicant.

**SECTION IV.** The South Bend Municipal Code is hereby amended at Chapter 2, Article 5, to add a new Section 2-60 which shall read in its entirety as follows:

## Sec. 2-60. South Bend Advisory Plan Commission.

- (a) The City of South Bend, prior to joining the St. Joseph County Area Plan Commission on January 1, 1965, had its own municipal plan commission, and it is now appropriate to return to a separate municipal plan commission as provided by Indiana law.<sup>1</sup>
- (b) The South Bend Advisory Plan Commission is established in the public interest of the City of South Bend with an effective date of December 1, 2019.
- (c) The representatives of the South Bend Advisory Plan Commission shall be nine (9) in number as prescribed in IC 36-7-4-207 as follows:
  - One (1) member appointed by the Common Council from its membership,
  - One (1) member appointment by the park board from its membership,
  - One (1) member or designated representative appoint by the city works board,

The city civil engineer or a qualified assistant, appointed by the city civil engineer, and

- Five (5) citizen members, of whom no more than three (3) may be of the same political party, appointed by the Mayor.
- (d) The term of office of the members appointed by the Common Council, the City's Parks Board, and its Board of Public Works is co-extensive with that member's term of office on the Council or Board, unless the Council or Board appoints at its first regular meeting in any year, another to serve as its representative. The qualifications of and the terms of membership of all other members of the South Bend Advisory Plan Commission shall be as required and provided by IC 36-7-4-200 et seq., and most applicably, IC 36-7-4-216 and IC 36-7-4-218.
- **SECTION V.** The South Bend Municipal Code is hereby amended at Chapter 2, Article 5, to add a new Section 2-61 which shall read in its entirety as follows:

## Sec. 2-61. South Bend Advisory Board of Zoning Appeals.

- (a) The City of South Bend joined the St. Joseph County Area Board of Zoning Appeals effective May 22, 2009, and it is now appropriate for the City to have its own Advisory Board of Zoning Appeals as provided by Indiana law.
- (b) The South Bend Advisory Board of Zoning Appeals is established in the public interest of the City of South Bend with an effective date of December 1, 2019.
- (c) The representatives of the South Bend Advisory Board of Zoning Appeals shall be five (5) in number as provided in IC 36-7-4-902 as follows:
  - Three (3) citizen members appointed by the Mayor, of whom one (1) must be a member of the plan commission and two (2) must not be members of the plan commission,
  - One (1) citizen member appointed by the Council, who must not be a member of the plan commission, and
  - One (1) member appointed by the South Bend Advisory Plan Commission from its membership, who must be a citizen member of commission other than the member appointed by the Mayor above.
- (d) The qualifications of and the terms of membership of the South Bend Advisory Board of Zoning Appeals shall be as required and provided by IC 36-7-4-900 et seq., and most applicably, IC 36-7-4-905 through IC 36-7-4-907 inclusive.
- **SECTION VI.** The City of South Bend will formally resign from the St. Joseph Area Plan Commission and the St. Joseph Area Board of Zoning Appeals on December 31, 2019.
- **SECTION VII.** This Ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.

The South Bend Common Council (the "Common Council") adopted three Confirming Resolutions confirming the designation of certain areas in the City of South Bend, Indiana as an Economic Revitalization Area for the purposes of granting tax abatement for real and vacant properties in conjunction with investment in construction of two new hotels and improvements to existing vacant building Hall of Fame.

Long story short, Dan Boecher has worked very hard to get the abatement process started. My husband, AJ Patel, and I have invested more than 20 million dollars into our community along with employing over 120 people between 2 properties and are asking in good faith for a

waiver for the items that were not filed due to my lack of knowledge of the process. I can say that I am fully aware of the process. I can't express enough how committed I am to making sure all forms will be filled out properly and on time...it will be my personal promise.

Our investments in our community were based upon the abatements that we were going to be receiving. Without having these abatements, it would hurt our business and hinder our growth in the community. WHEREAS, the St. Joseph County Assessor's office issued Notices of Assessment of Land and Improvements (Form 11) (each, the "Notice of Assessment") dated as of January 1, 2018 and January 1, 2019 with respect to the Real Property; and

WHEREAS, an Application for Deduction from Assessed Valuation of Structures in Economic Revitalization Areas (Form 322/RE) ("Form 322/RE") must be filed with the St. Joseph County Auditor (the "Auditor") before May 10 in the year in which the addition to assessed valuation (or new assessment) is made, or not later than thirty (30) days after the Notice of Assessment is mailed to the property owner if it is mailed after April 10; and

WHEREAS, Form 322/RE requires that Form CF-1/Real Property (Form CF-1) ("Form CF-1") must be attached to the Form 322/RE; and

WHEREAS, the Company filed a Form CF-1/Real Property with the City of South Bend on or about April 19, 2018 and May 6, 2019, however, the Company inadvertently did not file the Forms 332/RE with the Auditor; and

WHEREAS, the Company subsequently received a Tax Bill in April 2019 (the "Tax Bill") providing that the spring installment of 2018 property taxes on the Parcel were due May 10, 2019; and

WHEREAS, upon receipt of the Tax Bill, the Company filed Form 322/RE with the Auditor's office on or about June 20, 2019; and

WHEREAS, the Tax Bill, without the application of the abatement previously approved by the Common Council, results in a tax being due of \$56,784.56; and

WHEREAS, the Company timely remitted payment of \$28,397.28 to St. Joseph County Treasurer prior to the May 10, 2019 due date for Spring Taxes; and

WHEREAS, in order to receive the benefit of the granted tax abatement for two periods 2018 Pay 2019 and 2019 pay 2020 the Company has requested that the Common Council exercise its authority as the designating body to waive noncompliance by adopting a resolution pursuant to Section 11.3 of the Act;

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of South Bend, Indiana, as follows:

<u>SECTION I</u>. The Company has presented testimonial evidence of the following facts in support of this resolution:

- A. The Company states that while the Company did file a Form CF-1/Real Property Form with the City of South Bend, the Company mistakenly and inadvertently failed to file a Form 322/RE with the Auditor's office before May 10, 2018 and May 10, 2019.
- B. Upon receipt of the 2018 Tax Bill in April 2019, the Company filed with the County Auditor the Form 322/RE on or about June 20, 2019.
- C. The Company exceeded the project cost stated in the original petition for tax abatement. The initial cost of the project was estimated to be \$6,000,000 and the actual cost was \$6,604,373, which sum is made up of a land acquisition cost of \$581,067 and construction costs of \$6,023,306. The project has met the employment representation stated in the original petition for tax abatement from when the project began operating, until the present date.
- D. The project is a positive development to this community. The Company has enhanced the curb appeal of the area. The Company has created a beautiful lodging facility that was well needed to serve the Southside of South Bend.
- E. All other required documentation has been received from the Company by the required dates.

<u>SECTION II</u>. The foregoing facts, taken together, lead the Common Council to conclude that compelling reasons exist to waive the filing deadline.

SECTION III. The Common Council hereby waives the filing deadline of Form 322/RE by May 10, 2018 and May 10, 2019, and pursuant to Section 4.8 of the Act and Section 11.3 of the Act, adopts this resolution that authorizes acceptance.

<u>SECTION IV.</u> This Resolution shall be in full force and effect from and after its adoption by the Common Council and approval by the Mayor.



Please find enclosed the Petition for Waiver of Non-Compliance associated with the development referenced above. We request that this Petition be taken before the Common Council as soon as possible so that we can rectify this situation.

Based on discussions with the St. Joseph County Auditor, The LaSalle Apartments, LLC has learned that its tax abatement was only partially recognized by the Treasurer because The LaSalle Apartments, LLC inadvertently did not re-file Form 322RE in the spring of 2018.

While not a good reason for failing to file the proper form, we were unaware of the requirement to file Form 322RE in more than just the first year of the property tax abatement. Since our project was completed before the end of the year we assumed the full assessed value was being picked up in the first year and therefore there was no need to re-file Form 322RE. According to our property tax attorney, this requirement is fairly unique to St. Joseph County in Indiana. Again, we need to follow your rules, but this was an inadvertent oversight on our part. Other than this paperwork, we have fulfilled our commitments and delivered and have maintained a beautifully transformed building in downtown South Bend.

# A RESOLUTION OF THE CITY OF SOUTH BENDY CLERK, SOUTH BEND, IN WAIVING PETITIONER, THE LASALLE APARTMENTS, LLC NON-COMPLIANCE WITH IND. CODE §6-1.1-12.1.6 ET SEQ.

WHEREAS, The LaSalle Apartments, LLC is the owner of real property in the City of South Bend commonly called The LaSalle Apartments, South Bend, Indiana, on which The LaSalle Apartments, LLC has remodeled a nine story building formerly known as The LaSalle Hotel, which has been re-purposed as apartments and commercial space.

WHEREAS, in conjunction with The LaSalle Apartments, LLC's development of the former LaSalle Hotel, the City of South Bend granted The LaSalle Apartments, LLC a ten-year tax abatement which remains in effect and was codified as Resolution 4417-15, and

WHEREAS, it has come to the City of South Bend's attention that The LaSalle Apartments, LLC failed to timely file an abatement deduction application with the St. Joseph County Auditor for the following tax periods: Tax Year 2018 (Pay 2019), and, as a result, The LaSalle Apartments, LLC may lose the benefit of the ten-year tax abatement for following: Tax Year 2018 (Pay 2019), and

WHEREAS, pursuant to Ind. Code § 6-1.1-12.1-11.3 (2017), the City of South Bend has the authority to waive The LaSalle Apartments, LLC's failure to comply with Indiana's tax abatement laws and, specifically, the authority to waive The LaSalle Apartments, LLC's failure to file a timely or complete abatement deduction application with the county auditor, and

WHEREAS, the City of South Bend accepts that The LaSalle Apartments, LLC's failure to timely file its abatement deduction application was an excusable mistake which resulted through inadvertent over-sights, acknowledges that The LaSalle Apartments, LLC filed a deduction application promptly after learning of its mistake, and accepts that The LaSalle Apartments, LLC is taking steps to avoid this problem in the future, and

WHEREAS, pursuant to I.C. § 6-1.1-12.1-11.3(c), the City of South Bend has heard and considered The LaSalle Apartments, LLC's request for a waiver of non-compliance at a duly-called and public meeting of the Council,

### NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE CITY OF SOUTH BEND, INDIANA, THAT:

SECTION 1. Acting pursuant to the authority granted to it by I.C. § 6-1.1.-12.1-11.3 the City of South Bend hereby waives The LaSalle Apartments, LLC's failure to comply with Indiana's abatement laws and, specifically, waives The LaSalle Apartments, LLC's failure to file a timely or complete abatement deduction application with the county auditor for the following: Tax Year 2018 (Pay 2019).

SECTION 2. The City of South Bend hereby affirms that the ten-year tax abatement previously granted to The LaSalle Apartments, LLC as Resolution 4417-15 remains in effect and directs The LaSalle Apartments, LLC to file this resolution for record with The St. Joseph County Auditor and/or St. Joseph County Assessor.

SECTION 3. This Resolution shall be in full force and effect from and after its passage and approval, as required by law.

This text amendment to the current ordinance updates the statutory references and terminology to make the ordinance consistent with state statutes.

Please schedule this for first reading on September 9, 2019 with public hearing, second and third readings and public hearing on September 23, 2019.

AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF SOUTH BEND, INDIANA AMENDING CHAPTER 13, ARTICLE 5, SECTION 13-75.5 OF THE SOUTH BEND MUNICIPAL CODE TO ADD DEALING IN A CONTROLLED SUBSTANCE ANALOG TO THE LIST OF PROHIBITED ACTIVITIES CONSTITUTING A DISORDERLY HOUSE

#### STATEMENT OF PURPOSE AND INTENT

The South Bend Municipal Code prohibits various conduct which would constitute a disorderly house. The prohibited conduct includes, among other things, dealing with substances including synthetic drugs or synthetic drug lookalike substances. The current ordinance refers to State statutes in defining violations. The purpose of this amendment is to conform with recent amendments to State statutes defining "controlled substance analog" and eliminating the terminology "synthetic drug lookalike" which became effective July 1, 2019. The amendment also updates statutory references after the State Legislature repealed a number of statutes and enacted new statutes to replace them.

Sec. 13-75.5. - Disorderly houses; prohibited.

- (a) Definitions.
  - (1) For purposes of this section, *disorderly house* means a building, dwelling, establishment, premises or place where prohibited conduct occurs and it includes the outside area contiguous to and surrounding the structure such as a yard or lot under the same ownership. If the building, dwelling, establishment, premises or place is a multiple-unit dwelling or residence, hotel or motel, or commercial or office building, this definition applies only to that dwelling unit, room or suite of rooms in the hotel or motel, office rooms or suite, store, lot or yard in or on which prohibited conduct occurs.
  - (2) For purposes of this section, *owner* means:
    - (a) The recorded owner of the property, as determined by the records of the St. Joseph County Assessor's Office;
    - (b) Any party with an equitable interest in the property, provided that such equitable interest is recorded; and
    - (c) The trustee of a land trust, if the land trust holds title to such property.

- (3) For purposes of this section, *occupant* means any person over sixteen (16) years of age whose domicile is the property upon which the prohibited conduct has been found to have occurred.
- (4) For purposes of this section, *vacant* means a building which is lacking the habitual presence of human beings who have a legal right to be on the premises, or at which substantially all lawful business operations or residential occupancy has ceased.
- (5) For purposes of this section, *prohibited conduct* means activities occurring in violation of the statutes or ordinances relating to any of the following:
  - a. Gambling, as defined in IC 35-45-5-1;
  - b. Battery, as defined in IC 35-42-2-1;
  - c. Contributing to the delinquency of a minor, as defined in IC 35-46-1-8;
  - d. Resisting law enforcement, as defined in IC 35-44-3-3;
  - e. Disorderly conduct, as defined in IC 35-45-1-3;
  - f. Criminal recklessness, as defined in IC 35-42-2-2;
  - g. Discharge of firearms, as prohibited by Section 13-58 of the South Bend Municipal Code;
  - h. Unreasonable noise, as prohibited by Section 13-57 of the South Bend Municipal Code;
  - i. Failure to keep vacant property secured against entry, in violation of Section 6-37 or 9-2 of the South Bend Municipal Code, or IC 36-7-9-1 et seq. (Unsafe Building Law) or any other fire or property maintenance codes constitutes prohibited conduct regardless of whether the City has issued a citation for the violation, issued an order to secure, or taken action to abate the condition;
  - j. Failure to comply with Section 16-53, (Conditions Constituting Public Nuisances), Section 16-58, (Duties of Owners or Persons in Control of Vacant Lots), or Section 16-59, (Removal of Vegetation) of the South Bend Municipal Code constitutes prohibited conduct whenever the City has verified with the Department of Code Enforcement that such violation has occurred at the property three (3) or more times within a calendar year. Such violation constitutes prohibited conduct regardless of whether the City has taken action to abate the condition or conduct and regardless of whether the City has issued a citation for the violation;
  - k. Violations of any of the following Indiana statutes governing the sale, possession, delivery or receipt of alcoholic beverages:
    - 1. Sales, delivery or possession in violation of IC 7.1-5-1-1;
    - 2. Illegal possession by a minor in violation of IC 7.1-5-7-7;
    - 3. Furnishing alcohol to a minor in violation of IC 7.1-5-7-8;
    - 4. Inducing a minor to possess alcohol in violation of IC 7.1-5-7-15;
    - 5. Sale or delivery of alcoholic beverages to intoxicated persons in violation of IC 7.1-5-10-15;

- 6. Receipt of alcoholic beverages from a person who does not hold a permit in violation of IC 7.1-5-10-5;
- 7. Purchase of alcoholic beverages from a person who does not hold a permit in violation of IC 7.1-5-10-7; or
- 8. Visiting or maintaining a common nuisance or any other violation of IC 35-45-1-5.
- 1. Violations of any of the following Indiana statutes governing:
  - 1. Prostitution in violation of IC 35-45-4-2;
  - 2. Making an unlawful proposition in violation of IC 35-45-4-3; or
  - 3. Promoting prostitution or juvenile prostitution in violation of IC 35-45-4-4.
- m. Violations which constitute "racketeering activity" as defined by IC 35-45-6-1.
- n. Violations of any of the following Indiana statutes governing:
  - 1. Criminal gang activity in violation of IC 35-45-9-3;
  - 2. Criminal gang intimidation in violation of IC 35-45-9-4; or
  - 3. Criminal gang recruitment in violation of IC 35-45-9-5.
- o. Violations of any of the following Indiana statutes governing:
  - 1. Dealing in cocaine or a narcotic drug in violation of IC 35-48-4-1:
  - 2. Dealing in methamphetamine in violation of IC 35-48-4-1.1 and/or manufacturing methamphetamine in violation of IC 35-48-4-1.2;
  - 3. Dealing in a schedule I, II or III controlled substance or controlled substance analog in violation of IC 35-48-4-2;
  - 4. Dealing in a schedule IV controlled substance or controlled substance analog in violation of IC 35-48-4-3;
  - 5. Dealing in a schedule V controlled substance or controlled substance analog in violation of IC 35-48-4-4-4; or
  - 6. Dealing in marijuana, hash oil, hashish, salvia, a synthetic drug, as defined by IC 35-31.5-2-321 or IC 25-26-13-4.1 as those statutes are from time to time amended, or a controlled substance analog, as defined in IC 35-48-1-9.3 and/or IC 35-48-4-0.5 as from time to time amended, 35-48-4-4.6, 35-48-4-5, or IC 35-48-4-10. The distribution of low THC hemp extract in full compliance with IC 24-4-21-1 et seg. is excluded from this subpart.
  - 7. Use or possession of any of the substances described in subsections o.l. through and including 6., above, or the sale, use or possession of any other illicit narcotics or dangerous controlled substances.
  - 8. Dealing in a controlled substance by a practitioner in violation of IC 35-48-4-1.5

- (b) *Public nuisance*. Whenever prohibited conduct as defined in subsection (a) of this section occurs in or upon a building, dwelling, establishment, premises or place, the City deems the building, dwelling, establishment, premises or place to be a disorderly house and a public nuisance.
- (c) Notice to abate. Whenever the South Bend Police Department, or the Department of Code Enforcement, when acting alone or upon information from the Fire Department, the St. Joseph County Health Department, or other reliable source has a reasonable belief that prohibited conduct has occurred in or upon a building, dwelling, establishment, premises or place, the City shall notify the owner of the property, and the occupants of the property that the building, dwelling, establishment, premises or place is a disorderly house and as such constitutes a public nuisance and that they must abate the public nuisance.
- (d) *Manner of serving notice*. The City shall provide notice to the owner of the property and the occupants of the property in the manner provided by IC 36-7-9-25. The City deems the owner of the property and the occupants of the property responsible for any and all prohibited conduct occurring upon the premises after receipt of the notice.
- (e) Penalty, injunctive relief, and business license action. Whenever prohibited conduct occurs upon a property after the City has provided notice to abate the public nuisance, the City may file an action in any court of general jurisdiction against the owner and/or occupants to enjoin the nuisance and to recover a fine of not less than two hundred fifty dollars (\$250.00) and not more than two thousand five hundred dollars (\$2,500.00) with each day of violation constituting a separate offense. In determining the amount of the fine to be imposed, the court may consider the attempts of the property owners or occupants to address the public nuisance. The City may also suspend, revoke, or deny renewal of the business license of the owner and/ or occupant of the building, dwelling, establishment, premises or place where a violation of this section has occurred, as more specifically provided in Chapter 4, Article 2, Section 4-16 of this Code.
- (f) Eviction proceedings as a defense. No owner shall be liable for a violation of this section if such owner initiates an eviction proceeding within thirty (30) days of receipt of notice of the prohibited conduct set forth in this section, and diligently pursues eviction proceedings to completion.







Attached, please find a bill for consideration by the Common Council of the City of South Bend fixing the property tax rate for the City of South Bend for the fiscal year commencing January 1. 2020 and ending December 31, 2020. This tax rate will apply for property tax assessments in fiscal 2019 with taxes payable in fiscal 2020.

Similar to prior years, this bill has been filed with estimated property tax rates. The final property tax rates for each municipality in the State of Indiana are determined by the Department of Local Government Finance (DLGF) as part of the "1782" budget review process which, according to the state budget calendar, must be completed in February 2020. The actual property tax rates will depend on the 2019/pay 2020 net assessed valuation of property in South Bend.

This bill is respectfully submitted for 1st reading filing with the Common Council for the council meeting on September 9, 2019, 2nd reading and public hearing at the council meeting on September 23, 2019, with 3rd reading and council vote at the council meeting on October 14, 2019.

It is necessary to pass this Ordinance in order to levy taxes and fix the rate of taxation for the purpose of raising revenue to meet the necessary expenses for 2020.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF SOUTH BEND, INDIANA, AS FOLLOWS:

<u>SECTION I</u>. There shall be levied upon each One Hundred Dollars of Assessed Valuation of Taxable Property of the City of South Bend, Indiana, for the fiscal year 2019 to be collected in the year 2020 the following:

For CORPORATION GENERAL FUND, the sum of \$3.6406 on each one hundred dollars of Taxable Property.

For PARK AND RECREATION FUND, the sum of \$0.8566 on each one hundred dollars of Taxable Property.

For CUMULATIVE CAPITAL DEVELOPMENT FUND, the sum of \$0.0375 on each one hundred dollars of Taxable Property.



AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF SOUTH BEND, INDIANA, APPROPRIATING, ADOPTING AND APPROVING THE SOUTH BEND PUBLIC TRANSPORTATION CORPORATION'S 2020 BUDGET AND LEVYING THE TAX AND FIXING THE RATE OF THE TAXATION FOR THE PURPOSE OF RAISING REVENUE TO FUND THE SOUTH BEND PUBLIC TRANSPORTATION CORPORATION, SOUTH BEND, INDIANA, FOR THE FISCAL YEAR ENDING DECEMBER 31, 2020

Pursuant to Indiana law, the South Bend Public Transportation Corporation is required to submit its proposed budget and tax levy to the Common Council of the City of South Bend for adoption. Specifically, Indiana Code § 6-1.1-17-20 requires that the South Bend Public Transportation Corporation, as a political subdivision governed by a majority of unelected officials, submit its proposed budget and property tax levy to the Common Council of the City of South Bend. Pursuant to Indiana Code § 6-1.1-17-20(e), the Common Council of the City of South Bend is required to review the South Bend Public Transportation Corporation's budget and proposed tax levy and adopt a final budget and tax levy for the South Bend Public Transportation Corporation.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF SOUTH BEND, INDIANA, as follows:

SECTION 1. The South Bend Public Transportation Corporation's budget for the year ending December 31, 2020 in the sum of \$12,267,937.00, as shown on Budget Form 4-A, filed with the Common Council on August 22, 2019, is appropriated, adopted, approved and ordered set apart out of the several funds herein named and for the purposes herein specified, subject to the laws governing the same. Such sums herein appropriated shall be held to include all expenditures authorized to be made during the year, unless otherwise expressly stipulated and provided for by law. In addition, for the purpose of raising revenue to meet the necessary expenses of the South Bend Public Transportation Corporation, a total property tax levy of \$4,728,495.00 and a total tax rate of 0.1261 as shown on Budget Form 4-B are also appropriated, approved and adopted.

<u>SECTION 2.</u> This Ordinance shall be in full force and effect from and after its passage by the Common Council of the City of South Bend and approved by the Mayor.



An Indiana statute, 36-7-10.1-3 authorized the Common Council to enact ordinances requiring real estate owners to cut and remove weeds and other rank vegetation on the property. The statute requires that such an ordinance defines certain specified words and terms.

I am filing the attached proposed amendment to the Municipal Code to amend and clarify the necessary definitions of "Noxious weeds" and "Rank vegetation" in the current ordinance and to eliminate the unnecessary definition of "Natural Landscaping Vegetation". The elimination of "Natural Landscaping Vegetation" narrows the exemption to the nine-inch height limit to "hydrophytic vegetation."

I ask that this proposed amended ordinance be scheduled for first reading at our September 9, 2019 meeting with second and third readings and public hearing scheduled for September 23, 2019.

## **BILL NO. 38-19**





AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF SOUTH BEND, INDIANA, AMENDING CHAPTER 19 OF THE SOUTH BEND MUNICIPAL CODE TO INCLUDE AN AMENDED ARTICLE 2 REGARDING ABATEMENT REGULATIONS ADDRESSING TALL GRASS, WEEDS, NOXIOUS WEEDS, AND RANK VEGETATION

#### STATEMENT OF PURPOSE AND INTENT

Indiana Code 36-7-10.1-3 authorizes the legislative body of a municipality to enact ordinances requiring owners of real property to cut and remove weeds and other rank vegetation growing on the property. An ordinance adopted under the statute must meet certain requirements, including the definition of specified words and terms. This amendment amends and clarifies some necessary definitions and eliminates an unnecessary definition of "Natural Landscaping Vegetation". The elimination of this unnecessary definition narrows the exemption to the nine-inch height limit to "hydrophytic vegetation".

ARTICLE 2. - ABATEMENT REGULATIONS ADDRESSING TALL GRASS, WEEDS, NOXIOUS WEEDS, AND RANK OR OVERGROWN VEGETATION

Sec. 19-32. - Definitions.

For purposes of this article, the following definitions shall apply:

- (a) City shall mean the City of South Bend, Indiana.
- (b) Enforcement Authority shall mean the Department of Code Enforcement.
- (c) *Hydrophytic vegetation* are plants living in wetlands governed by the federal Clean Water Act.
- (d) Noxious weeds shall have the definition set forth in Indiana Code § 15-16-7-2 as that statute is amended from time to time.
- (e) Owner shall mean the owner of record listed in the records of the St. Joseph County Recorder's Office.
- (f) Rain garden shall mean a type of natural landscaping vegetation which are shallow, vegetated basins which collect and absorb runoff from rooftops, sidewalks, and streets.
- (g) Rank vegetation shall mean any plant growth, which is or may be harmful to the senses, health, or well-being of others. Trees, shrubberies, flowers, ornamental grasses

- are not considered rank vegetation. Pursuant to Indiana Code § 36-7-10.1-3 rank vegetation does not include agricultural crops, such as hay and pasture.
- (h) Sustainable landscaping includes vegetation which is carefully selected to avoid the use of invasive species which are in balance with the local climate and requires minimal use of fertilizers, pesticides, and water which are functional, visually pleasing and environmentally friendly.
- (i) Vegetation shall mean all plants, trees, shrubs and weeds.
- (j) Vegetation management tools include but not are limited to mowing, trimming, and using herbicides.
- (k) Weed shall have the definition set forth in Indiana Code § 15-16-4-40.

Sec. 19-33. - Maintenance and landscape regulations; excessive growth prohibited.

- (a) The owners of real estate located in the City shall use vegetation management and sustainable landscaping tools on the real estate's vegetation so that they are in compliance with this article, and do not become a public nuisance.
- (b) It is unlawful for the owner of real estate in the City to allow his or her real estate to become overgrown with weeds, grass, noxious weeds, rank vegetation or other vegetation in excess of the height of nine (9) inches or to such extent that the growth is detrimental to the public health and constitutes a public nuisance. It is unlawful for the owner of real estate in the City to allow any sidewalk or alley abutting such real estate to become overgrown with vegetation.
- (c) In light of the self-sustaining nature of hydrophytic vegetation and its ecological benefit, such vegetation is exempt from the nine (9) inch height requirement.

Sec. 19-34. - Consequences of failure to comply and continuous enforcement.

- (a) Any owner of real estate located in the City who fails to comply with the provisions of this article shall be subject to the enforcement procedures set forth in Section 16-59 of the South Bend Municipal Code.
- (b) A continuous abatement notice will serve as notice to the owner that each subsequent violation during the same calendar year in which the initial notice of violation was provided may be abated by the City without further notice. Such notice shall comply with Indiana Code § 36-7-10.1-3.

Sec. 19-35 - Penalties.

(a) Any person found in violation of a provision of this article shall be fined the sum of two hundred fifty dollars (\$250.00) per violation. Each day after the expiration date of any time limit ordered by the Board of Public Works or its designee for abating a nuisance condition shall constitute a distinct and separate offense. Any person found in violation of a provision of this article whose property becomes listed as a continuous enforcement property shall be fined the sum of five hundred dollars (\$500.00) per violation in that first calendar year of being listed.

Thereafter, each violation shall be fined and assessed administrative fees related to costs incurred by the City for inspections, abatement and administration and a penalty which shall be as follows:

	Fine Per Violation	Continuous Enforcement Fee for Administrative Expenses
2 <sup>nd</sup> year	\$750.00	\$400.00
3 <sup>rd</sup> year	1,000.00	450.00
4 th year and thereafter	1,500.00	500.00

- (b) This section supplements and does not limit any other remedy or action available in law or in equity being pursued by the Department of Law.
- (c) This ordinance shall be in full force and effect from and after its passage by the Common Council, approval by the Mayor and media publication.
