Bill No. 30-22

Angela Smith, Zoning Administrator for the City of South Bend with offices on the 14th floor of the County-City Building presented Bill *No. <u>30-22</u>*. Smith stated she received a request from the petitioner to table the bill for thirty (30) days in order to meet with property owners.

Committee Member Sheila Niezgodski motioned to table Bill *No. <u>30-22</u>* until <u>September 26, 2022</u>, which was seconded by Committee Chair Lori Hamann and carried by a vote of five (5) ayes.

Bill No. 36-22

Angela Smith, Zoning Administrator for the City of South Bend with offices on the 14th floor of the County-City Building presented Bill *No.* <u>36-22</u>. Smith stated the bill has not been heard by the Planning Commission and recommended that the Committee table this bill indefinitely.

Committee Member Sheila Niezgodski motioned to table Bill *No. <u>36-22</u>* indefinitely, which was seconded by Committee Member Karen White and carried by a vote of five (5) ayes.

Bill No. 38-22
