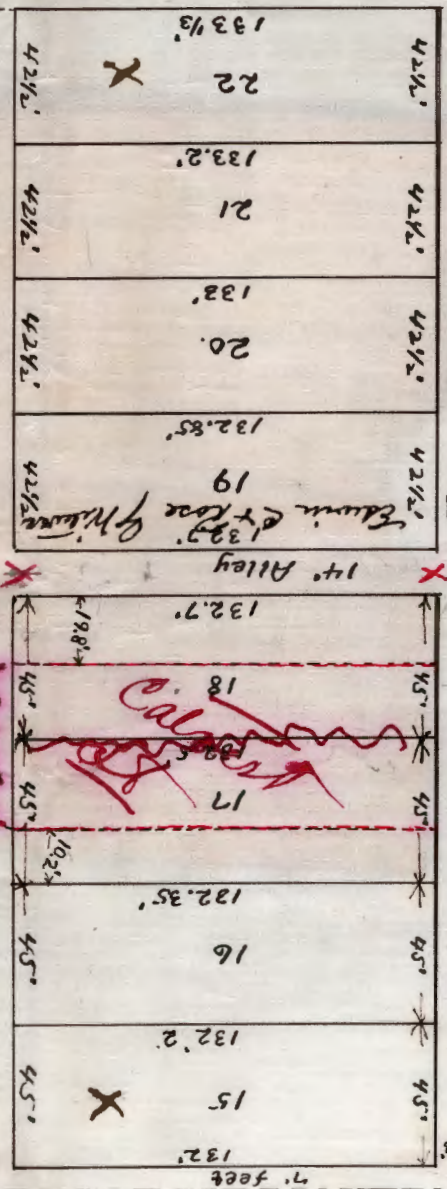

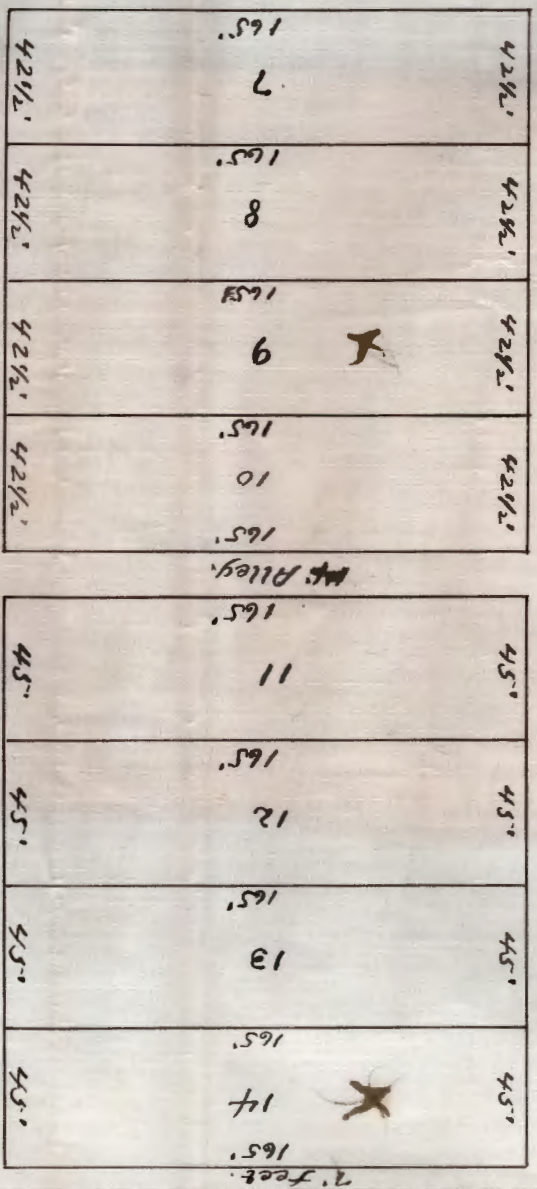


Tandelia Ry Co Right of Way
