



The undersigned, the School City of South Bend, Indiana, hereby represents to your honorable body that it has for many years past owned and been in possession of Lots Nos. 370, 371 and 372 in the Original Plat of the Town now City of South Bend; and that there has been for many years and now is located on said lots a brick school building, and that said lots and building are popularly known as the Madison School property.

Said lots are bounded on the East by Lafayette Street, on the West by a north and south fourteen (14) foot alley, on the South by Madison Street, and on the North by an east and west fourteen (14) foot alley.
