Notice of Resolution of Vacation No. 40.

Notice is hereby given that the Board of Public Works of said City at a meeting of said Board, held on the 24th. day of July 1917. 190 , adopted a resolution for the vacation of the following described property:

Vacation of a part of the alley between lots 10,11, 12 and 13 Chapin's Sub-Division of Bank Out Lots 1 and 2.

Beginning at a point on the east line of said alley 45.1 feet north of the north line of La Salle Avenue; thence north 14 degrees north 0 minutes east a distance of 60 feet to a point on the east line of said alley 41.1 feet southerly from the southerly line of Lincoln Way West measured along the easterly line of said alley; thence south 28 degrees 0 minutes west 8.8 feet; thence south 14degrees 0 minutes west 50.2 feet; thence south 2.5 feet to the place of beginning.

The following property may be injuriously or beneficially affected by such vacation.

Lot 10 Chapin's Sub-Division of Bank Out Lots 1 and 2 owned by William A. & Clara D. Jackson.

All of lot 11 Chapin's Sub. Division of Bank Out Lot 1 and 2 Trustees of St. Peter's Evangelical Church of South Bend, Indiana.
