**COPY OF VACATION RESOLUTION.**

No. 41, 1917

**RESOLVED BY THE BOARD OF PUBLIC WORKS OF THE CITY OF SOUTH BEND, INDIANA:** That it is desirable to vacate the following: The easterly part of Huey Street from Lincoln Way West to the south line of lot 40 Melrose Addition as follows, to-wit:-

Beginning at a point on the southerly line of Lincoln Way West sixty (60) feet east of the west line of Huey Street; thence south to a point on the south line of lot 40 Melrose Addition produced, sixty (60) feet east of the west line of Huey Street; thence east 25 feet more or less to the west line of lot 40 Melrose Addition; thence north on the west line of lots 40 to 52 of Melrose Addition produced to the north line of Prast Street; thence west 17 feet more or less to a point 63.2 feet east of the west line of Huey Street; thence north to a point on the southerly line of Lincoln Way West 64.2 feet east of the west line of Huey Street; thence westerly along the southerly line of Lincoln Way West to the place of beginning. Excepting all the intersection with Frederickson Street and Prast Street.

The following property may be injuriously or beneficially effected by such vacation: All of lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17 and east 144 feet of lot A. in John Prast's Sub-Division, lots 40, 41, 42, 43, 44, 45, 46, 47, 48, 49, 50, 51 and 52 Melrose Addition and the west 135 feet of lot 14 Kunstman and Meyer's Addition.

Notice is hereby given that the Board of Public Works of said City at a meeting of said Board, held on the 28th day of August 1917, 190, adopted a resolution for the vacation of the following described property:

The easterly part of Huey Street from Lincoln Way West to the south line of lot 40 Melrose Addition as follows, to-wit:-

Beginning at the point on the southerly line of Lincoln Way West sixty (60) feet east of the west line of Huey Street; thence south to a point on the south line of lot 40 Melrose Addition produced, sixty (60) feet east of the west line of Huey Street; thence east 25 feet more or less to the west line of lot 40 Melrose Addition; thence north on the west line of lots 40 to 52 of Melrose Addition produced to the north line of Prast Street; thence west 17 feet more or less to a point 63.2 feet east of the west line of Huey Street; thence north to a point on the southerly line of Lincoln Way West 64.2 feet east of the west line of Huey Street; thence westerly along the southerly line of Lincoln Way West to the place of beginning. Excepting all the intersecting with Frederickson Street and Prast Street.
