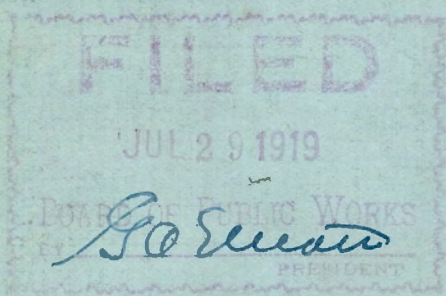

TO THE BOARD OF PUBLIC WORKS OF THE CITY OF SOUTH BEND:

The undersigned respectfully represents that he is the owner in fee simple of Lots 57, 58, 59, 60, 61, 62 and 63 and a tract of land lying immediately east of said lots 62 and 63 and south of said lot 59, all in the Second Plat of Chippewa Heights, now a part of the city of South Bend. He prays that the driveway known and designated on said plat as Robinhood Court be vacated; that the said driveway is entirely surrounded by the lots above mentioned and does not connect any two highways or in any manner affect any property of any person other than the undersigned.
