The northernmost 15' strip of property from the northwest corner of Lot A in E&M Goerner Replat thence east along Lots 47, 41 and 35 of Sorin's 2<sup>nd</sup> Addition Part located in E&M Goerner Replat and Sorin's 2<sup>nd</sup> Addition, South Bend, St. Joseph County, Indiana.



The staff has reviewed this petition relative to IC 36-7-3-13. It is the staff's opinion that:

- (2) The vacation would <u>not</u> make access to the lands of the aggrieved person by means of public way difficult or inconvenient.
