hereby determines that it is desirable to vacate said property.

SECTION II. The City of South Bend hereby releases the rights and easements of all utilities held by the Municipal City of South Bend, Indiana to construct and maintain any facilities, including, but not limited to, the following: electric, telephone, gas, water, sewer, surface water control structures and ditches, within the vacated right-of-way.


<u>SECTION III.</u> The following property may be injuriously or beneficially affected by such vacating:

<u>SECTION V.</u> This ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.


