Please find attached a drawing showing the platted streets for Crescent Oaks and the proposed relocation of the streets. The plat was recorded by Abonmarche and then an error was discovered in the survey of the land. The lots and streets are four feet to far North and ten feet to far East. So Abonmarche has begun the process of vacating the streets in the subdivision. Once this has been completed they will re-dedicate the streets in the proper location using a re-plat. We have checked the sewer and water mains that have been installed for the subdivision and they appear to be in the proper location so no problems should occur in the future with tapping the sewer and water for new houses.

No property has been transferred from Weiss so no problems will be encountered with ownership. And since no City services have begun in the subdivision the other City agencies will not need to review the proposed vacation.
