EASEMENT

THIS INDENTURE WITNESSETH: That FRED CORPORAN and MARGARET CORPORAN, husband and wife, of St. Joseph County, Indiana, and ALICE M. DUCK, of Cook County, State of Illinois, hereby grant and convey unto the CITY of SOUTH BEND, its successors and assigns forever, the right to construct, operate and maintain a sewer for the disposal of sewerage, and the right to enter upon and over certain property, hereinafter described, for the purpose of repairing and maintaining said sewer, and the right to dig up the surface of said property, for the purpose of repairing, maintaining and re-constructing said sewer through, over and upon the following described real estate, to-wit:

Beginning at a point South eighty-two (82) degrees West of and fifteen and eighty-three hundredths (15.83) feet from the Northeast corner of Lot Number 34 in Corporan and Duck's Subdivision of Lot Number 378 in Fordhams Addition to River Park, now a part of South Bend, Indiana, thence South three (3) degrees twelve (12) minutes East on a line fifty-four (54) feet more or less to the St. Joseph River, thence South eighty-six (86) degrees forty-eight (48) minutes West on a line twelve (12) feet; thence North three (3) degrees twelve (12) minutes West on a line fifty-four (54) feet more or less to the South line of North Side Boulevard; thence North eighty-two (82) degrees East on a line, said line being the South line of North Side Boulevard, to the point of beginning.
