Dear John:

Supplementing our telephone conference we have discussed the matter of the securing of easement from Mr. Sayre with Mr. Andrysiak, the City Engineer.

In accordance with Mr. Andrysiak's suggestion we have prepared a form of deed of dedication covering the thirty feet of realty which the City needs dedicated for street purposes.
