## EASEMENT

East of the East Property Line of Michigan St.; thence Southeasterly to a point on the Southerly boundary of the above described parcel which is a distance of 189.1 ft. East of the East Property Line of Michigan St.; thence Easterly along said Southerly boundary a distance of 8.0 ft.; thence Northwesterly to a point on the Northerly boundary of the Middle 22 ft. of the South 66 ft. of Lot 91 in the Original Plat of South Bend, which is a distance of 190.8 ft.
