EASEMENT

In consideration of one (\$1.00) dollar and other valuable considerations, receipt of which is hereby acknowledged, the undersigned grants to the City of South Bend, Indiana, or its successors, the right to lay, maintain, operate, alter, repair and remove a sewer, together with all manholes, structures, pumping stations and appurtenances connected therewith, through and over and under the following described real estate, to-wit:

Beginning at a point on the Northerly boundary of Lot 76 in the Original Plat of South Bend, which is a distance of 195.4 ft. East of the East Property Line of Michigan St.; thence Southeasterly to a point on the extension of the Southerly boundary of the North 75 ft. of Lot 76 in the Original Plat of South Bend, which is a distance of 216.9 ft. East of the East Property Line of Michigan St.; thence Easterly along said Southerly boundary a distance of 8.0 ft.; thence Northwesterly to a point on the Northerly boundary of the above described parcel which is a distance of 203.4 ft. East of the East Property Line of Michigan St.; thence Westerly along said Northerly boundary a distance of 8.0 ft. to the place of beginning.

The undersigned further grants to the City of South Bend,
Indiana, the right to enter upon said premises at any time with
