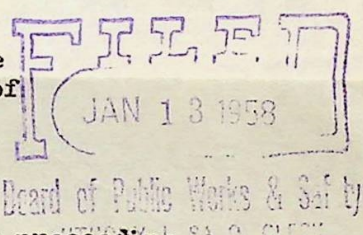

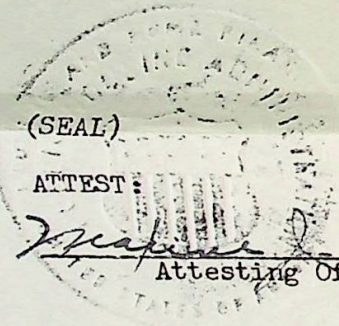
The United States acquired said property as part of a condemnation proceeding Case #2077 in the United States District Court of Northern Indiana, South Bend Division.

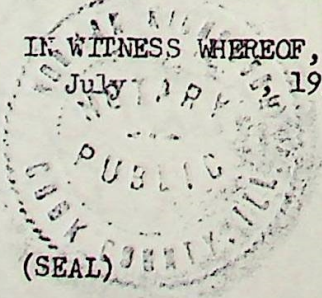
