Councilmember Lee asked what the City will do to get residents into the new jobs at the battery plant.

Mayor Mueller stated that General Motors and the City are currently having conversations regarding job qualifications and outreach.

Councilmember White requested information regarding CRB funding.

Mayor Mueller stated that conversation regarding CRB funds will be defined more clearly once there is an established director.

Councilmember Lee opened the public hearing.

Brian Frazier, 52791 Hill Trail, South Bend IN 46628, asked if it is too late to add line items to the budget for youth outreach opportunities at the 2023 Texas Southern University (TSU) and Notre Dame football game.

Mayor Mueller stated that they can discuss possible funding.

Maryland DeShaw, 2514 Kenwood Avenue, South Bend IN 46628, asked what Potawatomi Park will be receiving.

Mayor Mueller stated that Potawatomi Park needs expansions of their parking lots, pool renovation planning, as well as other renovations.
