THIS INDENTURE WITNESSETH, that STUDEBAKER CORPORATION, a Michigan corporation, hereby grants to THE CITY OF SOUTH BEND, INDIANA, a Municipal corporation, its successors and assigns, forever, for and in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, receipt whereof is hereby acknowledged, a right-of-way and easement, with the right, privilege and authority to said Grantee, its successors and assigns, lessees and tenants, to construct, erect, install, operate and maintain in a closed trench or ditch, below ground level, a line or pipe for the purpose of transmitting storm water and sanitary sewerage in, through, or under the following described real estate situated in St. Joseph County, State of Indiana:
