DEDICATION OF SUMMIT DRIVE BETWEEN WESTERN AVENUE  
AND NORTH LINE OF BELLEVILLE UNIT "F"

We, the undersigned, Belleville Investment Company, Inc., owners of the real estate shown and described herein do hereby dedicate part of street known as Summit Drive heretofore not dedicated, but accepted for perpetual maintenance of pavement and sewer by the Board of Public Works and Safety, on or about November 18, 1959, and so confirmed by R. S. Andrysiak, City Civil Engineer, on November 18, 1959.

This street shall be known and designated as Summit Drive in the City of South Bend, St. Joseph County, Indiana, described as follows:

A parcel of land located in the Southeast 1/4 of Section 8, Township 37 North, Range 2 East, South Bend, Indiana more particularly described as follows:

Beginning at the Northeast corner of lot 807 as shown on the recorded plat of Belleville Unit "F", an addition to the City of South Bend, Indiana; thence North along a line when prolonged North would coincide with the West line of Summit Drive as shown on the recorded plat of Mayflower 1st Unit, an addition to the City of South Bend, Indiana, 333.22 feet to the South line of Western Avenue; thence East along the South line of Western Avenue 80 feet; thence South 332.83 feet to the Northeast corner of said recorded plat of Belleville Unit "F", thence West along the North line of said plat of Belleville Unit "F", 80 feet to the place of beginning.

The size, width of said part of Summit Drive are marked on attached exhibit in feet and fractions, and is hereby dedicated to the public.

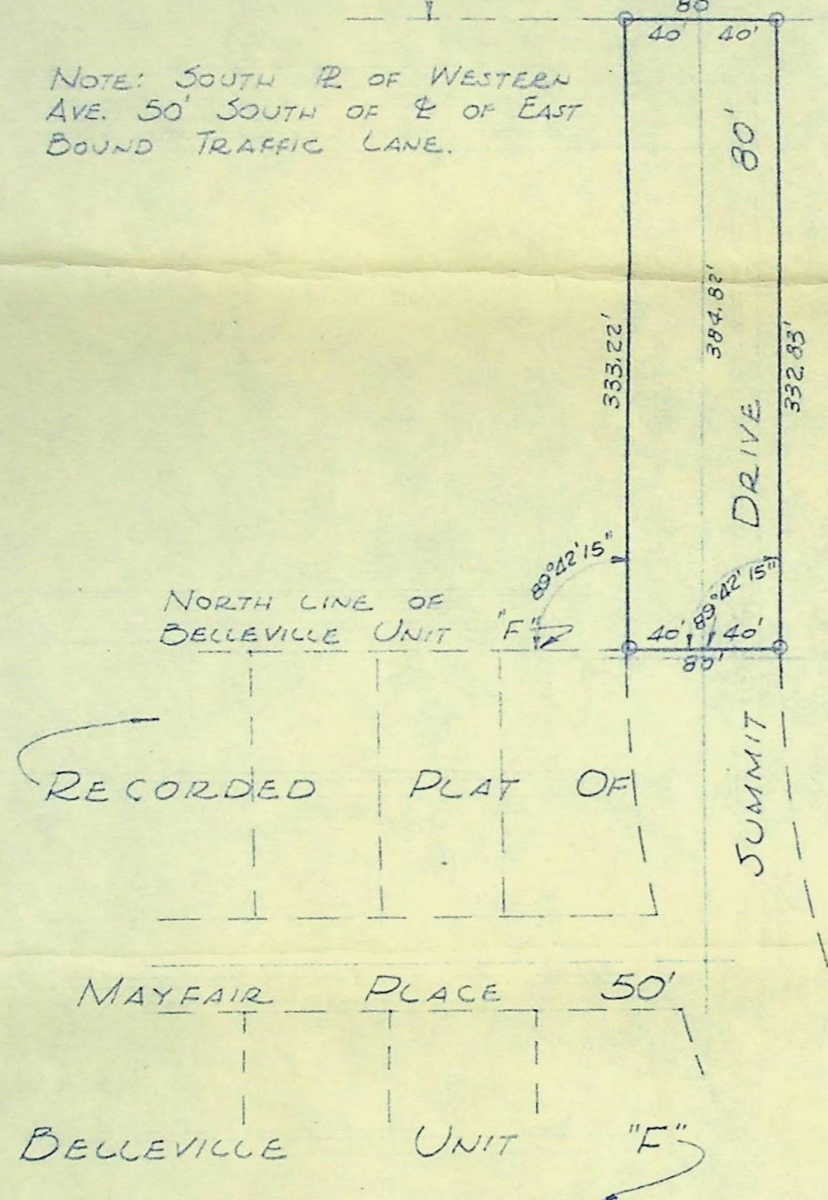

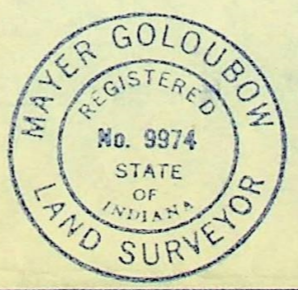
