Eric Horvath stated that the bonds have not yet been sold, and that they will be sold through the State Revolving Fund (SRF) process. The cost of issuance is one hundred and fifty thousand dollars (\$150,000).

Kyle Willis, City Controller, with offices on the 12th floor of the County-City building, stated that most of the bonds will have an interest rate between two point five percent (2.5%) and three percent (3%).
