That the undersigned, South Bend Community School Building Corporation, for the sum of One (\$1.00) dollar and other consideration, including but not limited to the acceptance hereof by the City of South Bend, Indiana, does hereby grant and convey to the City of South Bend, its Water Works Department, assigns, lessees and contractors, an easement for the purpose of constructing and maintaining an underground water main, together with the right to repair, replace and renew said water main, reserving, however, the right to the Grantor to construct or permit the construction of other utilities over, along and through said easement so long as the same do not interfere with said water main, and which utility easement shall be through the property of the undersigned of which the undersigned is lawfully seized and which utility easement is more particularly described as follows:

A part of the North Half of the Northwest Quarter of Section 31, Township 37 North, Range 3 East St. Joseph County, Indiana, and further described as follows:
