EASEMENT AND RIGHT-OF-WAY

IN CONSIDERATION of the sum of One Dollar (\$1.00) and other valuable consideration, receipt of which is hereby acknowledged, the undersigned, Viola P. (Lybarger) Fisher,

does hereby release, grant, transfer and deliver unto the Civil City of South Bend, Indiana, a permanent easement and right-ofway, for the following purposes, namely: The right to enter upon the hereinafter described land, at any time that it may see fit, for the purpose of constructing, maintaining and repairing, installing and renewing any water, sewer, and other utility facilities, including but not by way of limitation, drainage structures for both sanitary and storm sewer facilities, on, over, and across the ground embraced within the right-of-way hereinafter described in St. Joseph County, Indiana, to-wit:

The West Ten (10) feet of the following described tract of land:

A part of the West Half (W_2) of the Northwest Quarter (NW4) of Section Number Twenty-five (25), Township Number Thirty-seven (37) North, Range Number Two (2) East, described as follows: viz:

Beginning at a point on the West side of the Michigan Road 420 feet North of the center of the Ireland Road (formerly Ice Road); thence Northerly along the Westerly line of said Michigan Road, 50 feet; thence West 150 feet; thence Southerly parallel with the said Michigan Road, 50 feet; thence East 150 feet to the place of beginning, and being Lot Number Four (4) as shown on an unrecorded Plat of John A. Byer's Proposed Addition in Centre Township.

Subject to the existing easement held by Indiana & Michigan Electric Company and applicable zoning ordinances.

Casement -4 - Let 4

To have and to hold the said easement and right-of-way unto the Civil City of South Bend, Indiana, and unto its successors and assigns forever.

The grantee, by acceptance of this easement, agrees that at the time of initial installation and in the event of maintenance, replacement or renewal, it will restore said premises to the condition existing prior to the exercise of its rights hereunder. Blacktop, paving and other improvements shall be restored promptly and at the expense of the Civil City of South Bend, Indiana.

The grantors reserve the right to use said premises for any purpose not inconsistent with the easement granted hereunder.

The grantors also reserve the right to have a "Y" installed in the proposed sewer line at a location designed by the grantors to serve their present house located on Lots numbered 17 and 18, and the grantors have permission to connect this sewer to this house, with the expressed knowledge that Lots numbered 17 and 18 will be assessed for the sewer constructed in Main Street in front of said lots 17 and 18.

And the said grantors hereby covenant with the Civil City of South Bend, Indiana that they are lawfully seized and possessed of the aforementioned tract or parcel of land; that they have a good and lawful right to sell and convey; that it is free from all encumbrances; and that they will warrant and forever defend the title in quiet possession thereto against the lawful claims of all persons whomsoever.
