Beginning at the northeast corner of Lot 315 in part of Cottrell's 1st Addition to Lowell in the City of South Bend, Indiana; thence south ten (10) feet along the east line of said Lot 315; thence northwest to a point on the north line of said Lot 315 which is thirty-five (35) feet west of the place of beginning; thence east thirty-five (35) feet along the north line of said Lot 315 to the place of beginning, containing approximately 175 square feet.

Also starting at the northeast corner of Lot 315 in part of Cottrell's 1st Addition to Lowell in the City of South Bend, Indiana; thence due east fourteen (14) feet to the northwest corner of Lot 321 in said Addition; thence south ten (10) feet along the west line of said Lot 321; thence west fourteen (14) feet to the east line of said Lot 315 which point is ten (10) feet south of the northeast corner of said Lot 315; thence north ten (10) feet to the place of beginning, containing 140 square feet.
