Committee Chair Niezgodski called to order the Public Works and Property Vacation Committee meeting at 5:00 p.m.

Substitute Bill No. <u>24-22</u>—Resolution of the Common Council to Appoint the Board of Public Works and the Department of Public Works as Its Agents for Overseeing the Guaranteed energy savings Contact for the South Bend Wastewater Treatment

Erik Horvath, Director of Public Works with offices on the 14th floor of the County-City Building spoke regarding Bill *No. <u>24-22</u>*. The Bill is not for the Council due to the Board of Works having jersidiction.

Rick Anderson, Account Executive with Veregy, the petitioning company, spoke in support of Bill *No. <u>24-22</u>*. Rick Anderson stated that Veregy have done many similar projects across the state. This project will save money over time as it adds to the energy grid through renewable sources.
