thence; due South along a line 20 feet West of and parallel to the East line of said Section 28 a distance of 264 feet to the point of beginning, describing a permanent right-of-way easement 25 feet wide East and West and 264 feet long North and South, all in German Township, St. Joseph County, Indiana.

BE IT FURTHER RESOLVED that if preceding is brought by condemnation for the acquisition of such real estate, such proceedings shall be brought pursuant to the provisions of Acts 1905, Chapter 48, being I.C. 32-11-1-1, 32-11-1-13, as amended.
