James Mason, Director of Custodial Services, with offices at 737 Beale Street, South Bend, IN 46616. Kendra Key, Legal Counsel for SBCSC, with offices at 737 Beale Street, South Bend, IN 46616. Jospeh Summers stated that SBCSC requests the change to deem only the Jefferson School building as a historic landmark because the SBCSC intends on making improvements to the other service buildings on the property.
