Superintendent Carl J. Steen was called home to be with the Lord on Friday May 13, 2005, from Memorial Hospital. An anointed man of God, his life was full of love for his family, and friends, humor and a passion for the service of the Lord as a minister of the gospel. He positively influenced people's lives.

He was born May 1st, 1932, in South Bend, Indiana.

He attended Oliver School

He graduated from South Bend Central High School in 1950.

He married Genevieve Hudson of Milwaukee, Wisconsin in 1955.

He enhanced his education at Indiana University of South Bend.

He served in the United States Air Force as an airborne radio operator from 1952-1956 in the Korean War and spent time as an inactive reserve from 1956-1960.

In 1976 he received his Doctor of Divinity degree from Universal Bible Institute.

In 1993 he received a Doctor of Theology degree from Charles Harrison Mason Bible College and School of Theology.

Supt. Carl Steen, Sr. worked for 30 years at the Bendix Corporation, now known as Honeywell International as an operator in brake department 5B. He retired in 1981 and was a member of the United Auto Workers Union.

His lifelong mission was to answer the call Jesus Christ placed upon his life. He accepted Christ at the tender age of twelve and was called by Jesus Christ into the ministry of the gospel at the age of twenty-four.

He was appointed Pastor of Saints Memorial Church of God in Christ in October 1972 and led the congregation for 32 years. He worked diligently at motivating, inspiring and urging people to commit their lives to Christ.

While he was a great preacher and teacher, during his leadership Saints Memorial establishing numerous ministry programs to provide people in the South Bend Community a helping hand.

During his leadership tenure, Saints Memorial has offered daycare ministries, after school tutorial programs, food distribution services and financial assistance programs.

The church also provided working ministerial efforts at prisons, juvenile facilities, hospital chaplain services and retirement communities in which he fully participated. After the Bennett-Davis Educational Annex was added to the church in 1992 the Charles Harrison Mason Bible College and School of Theology established a South Bend campus for the local community.

In his life he received numerous awards and appointments. In 1993 he was appointed as Regional Director of C.H. Mason Bible College and School of Theology and to the Board of Directors of the Northern Indiana Food Bank. In 2000 he was inducted into KWANZAA African American Council of Elders.
