The samples were analyzed by NIOSH Method 7400 using Phase Contrast Microscopy at 400 - 450X magnification. Method 7400 measures the concentration of all fibers present, asbestos and non-asbestos.

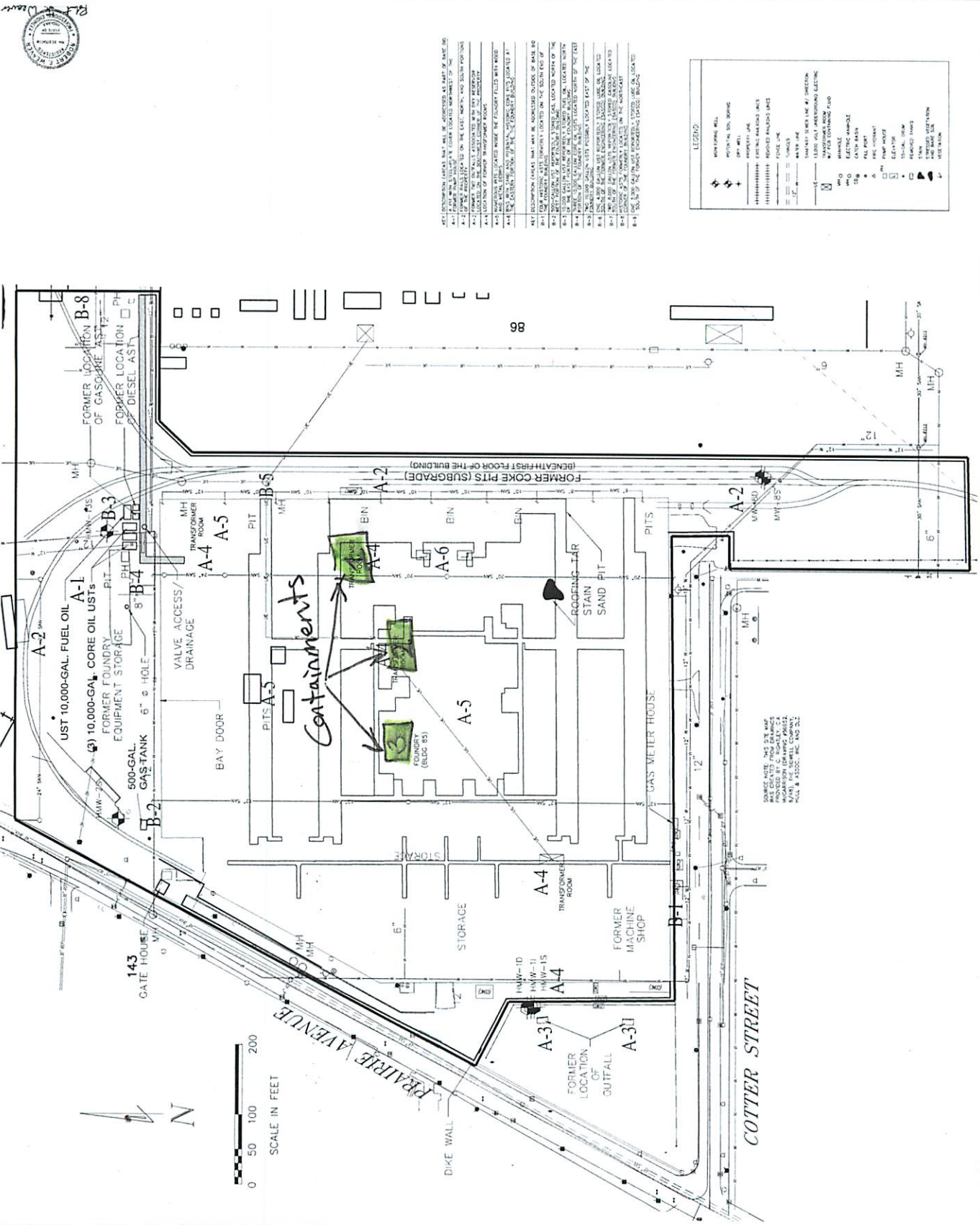
