Dear Mr. Laurent:

As per our phone conversation on April 30, 2003 this is a follow up letter concerning the lead contaminated waste pile located on the north central part of the Oliver Plow Works property just south of the railroad tracks.

Because of the ongoing Volunteer Remediation Program (VRP), the waste pile can be stored on site for as long as necessary to secure proper final disposal. You are not bound to the less than 90-day storage time frame as a Large Quantity Generator (LQG). We would encourage the city to facilitate the disposal as quickly as possible to alleviate any environmental mishaps or concerns.

IDEM asks that the pile be covered with visqueen or plastic and secured down so that rain will not contact the pile and thus run off and leaching of contaminants will be kept at a minimum. The pile should also be inspected weekly with documentation kept on file. This should be done to assure that the pile remains intact, covered, no animals are burrowing into it and that it has not broken containment.
