

# Urban Enterprise Association V2V Repair Matching Grant Program: Contact 574-235-5879 Homeowner

Provides matching grant funds to repair a vacant and abandoned residential property. Applicant may receive up to \$10,000 to make repairs first, that address any Code violations. Applicant must agree to reside in the house as their primary residence for at least 3 years. Applicant must provide a minimum of 20% matching funds for the qualifying repairs.

Provides matching grant funds to repair a vacant and abandoned residential property. Applicant may receive up to \$10,000 to make repairs first, that address any Code violations Applicant must agree to own and use the house as a rental property for a minimum of 3 years. Applicant must provide a minimum of 100% matching funds for the qualifying repairs.

### Vacant and Abandoned Resident Legal Assistance Program: Contact 574-235-5879

Provides assistance to residents of South Bend interested in acquiring a vacant lot where an abandoned house once stood.

Property must be used for qualifying use: side yard of applicant's primary residence or other neighborhood use/greenspace as approved by the City.

Qualifying applicants will be referred to the Notre dame Clinical Law Center for legal assistance.

Provides funding for costs associated with filing paperwork to obtain ownership.
