The South Bend Common Council will hold a limited Common Council meeting on April 13, 2020. The Common Council will hear only bills and ordinance amendments regarding changes to allow the City and the Mayor to take specific actions to function during the COVID-19 pandemic. This is being done in compliance with Governor Holcomb's Executive Orders.

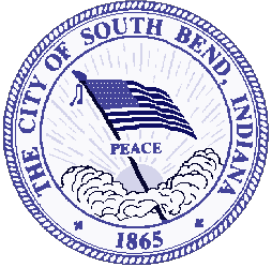
