The Office of the City Clerk will have walk-in strict procedures to maintain the safety of our residents and members of the public:

• We encourage residents to call and make an appointment. Residents can call (574)-235- 9221 or email <u>sbcityclerk@southbendin.gov</u>. Residents and guests must wear a face mask prior to entering the office. If you are ill, please stay home. While entering the County-City building, please practice proper social-distancing and use hand sanitizers stations throughout the building.
