 - Still working to get DFO system updated of vendors who are certified
 - \$1.9 million in W/WBE Purchase orders issued since DFO system was launched (May 1, 2020)
 - Public Works and Micheal Patton team are working to keep track of subcontractor payments.

 - City has sought information from 2019 disparity study
 - The attorney has responded to the request
 - The city is reviewing the attorneys information within the frame of the law
 - Plan to have more information to share next board meeting
