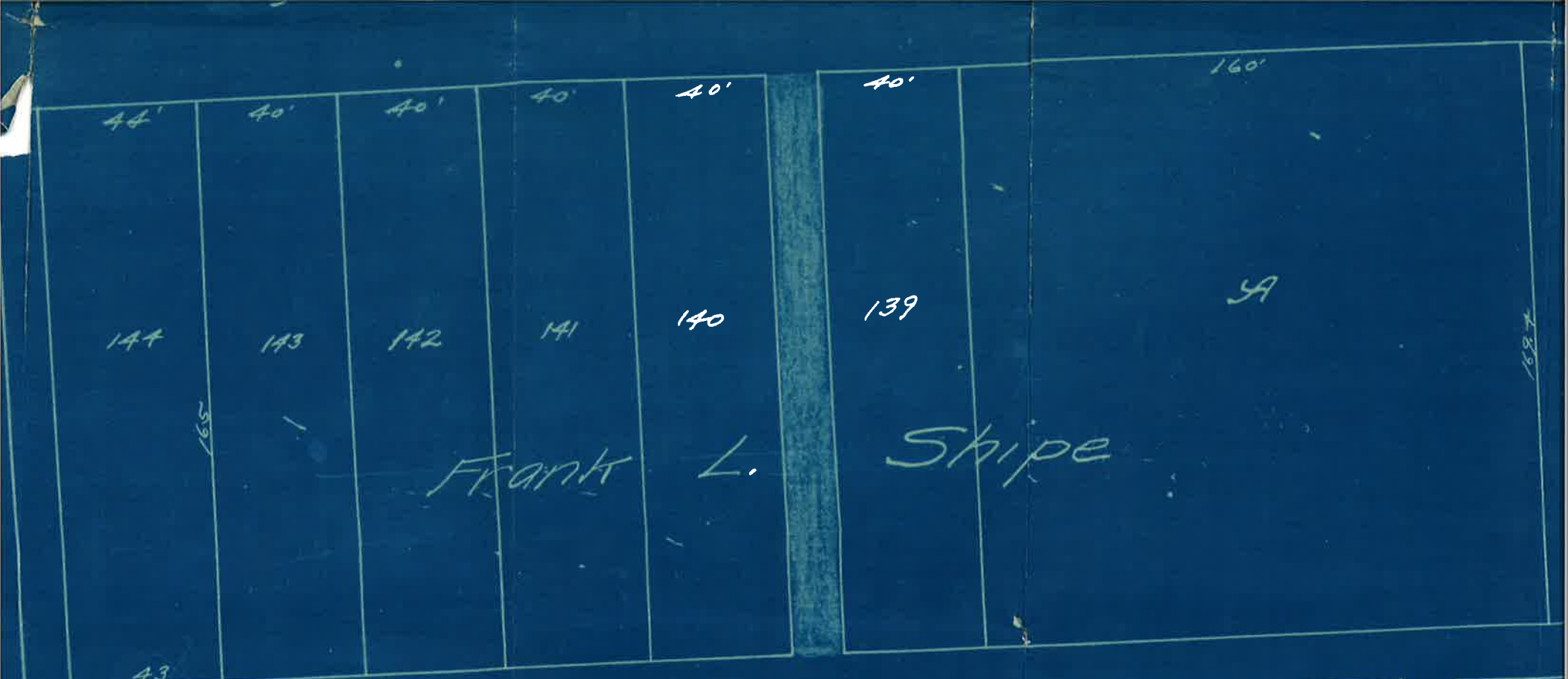

# COPY OF VACATION RESOLUTION.

No. 61, 1909

RESOLVED BY THE BOARD OF PUBLIC WORKS OF THE CITY OF SOUTH BEND, INDIANA: That it is desirable to vacate the following:

Alley lying between lots 139 and 140 in Wenger and Kreighbaums 2nd Addition.

The following property may be injuriously or beneficially effected by a vacation:

Lot "A" Wenger & Kreighbaums Addition. Frank L. Shipe, also all of Lots 139, 140, 141, 142, 143, 144 Frank. Shipe. Wenger & Kreighbaums 2nd. Addition. All of Lots 138, 124, 125, 126, 7, 128, 129, Wenger & Kreighbaums 2nd. Addition, C. M. Wenger & Martha Kreighbaum.

Notice of this resolution shall be published on the 29 day of Dec 1909 and the 5 day of Jan 1910 in the South Bend Daily Tribune.

This Board, at its office in the City Hall on the 18 day of Jan 1910 at 10 am will hear and receive remonstrances from all persons interested in or affected by these proceedings.
