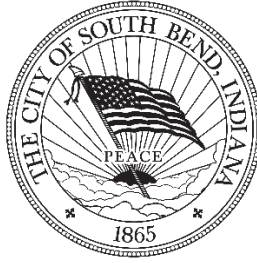

Bio

The steps of a good man are ordered by the Lord; and he delighteth in his way." Psalm 37:23.

Samuel L. Diggins, Sr. was a man whose life was a testament to the power of faith, love, and hard work. Born to Bennie F. Diggins and Dempsey L. Diggins on July 17, 1937, in Forrest City, AK, he embraced a life of purpose as a devoted servant of God, a dedicated husband, a loving father, and a skilled carpenter. His journey on this earth was a remarkable one, filled with unwavering devotion and a steadfast commitment to his beliefs and family.

He graduated from Lincoln High School in Forrest City, AK and relocated to South Bend, IN, where he met and married the love of his life Ruth Watkins on May 27, 1961 - married for 62 years. His dedication to his family was unparalleled. He was a loving and supportive husband who cherished his wife and stood by her side through life's joys and challenges. As a father, he instilled in his children the values of integrity, hard work, kindness and belief in God. He led by example, demonstrating the importance of nurturing relationships, fostering open communication, and providing a strong foundation for his family to thrive - sons Randall (Pamela) Diggins, Samuel (Deborah) Diggins Jr, Jeffery (Mia) Diggins Sr, Namurt (Rebecca) Diggins, Sean Diggins, and his daughter Dawn Diggins; 18 grandchildren, 14 great-grandchildren and 8 great-great grandchildren.

Samuel L. Diggins, Sr retired from the South Bend Community School Corporation after 17 years of service. He was the owner and operator of Diggins Painting and Drywall. His unique style of interior decorating was indicative of his talents. His skill and craftsmanship were renowned. He approached every project with meticulous attention to detail and a commitment to excellence. His work was not merely a means to an end but a reflection of his character. He also loved to sing with his family group The Sons of Glory, Harmony Kings and the Glory Travelers.

He accepted the call to ministry and in 1987 he accepted the leadership responsibility of Believers COGIC and was officially installed as pastor by Bishop David Blakely of Indiana First Jurisdiction. He led the Believers congregation for 36 years and was the Superintendent of True Vision District.

He loved God and the church and worked tirelessly at building the kingdom of God, there were no denominational nor racial barriers, as his dream was to have a multicultural ministry. With unwavering faith, he stood on the foundational teachings of The Church of God in Christ as his model to win souls to Christ. He led a life to be honored. His deep-rooted faith guided his every step. He found solace and strength in his relationship with God, and this foundation would shape the trajectory of his life. As a man of God, he exemplified compassion, humility, and forgiveness. He lived out his faith with unwavering conviction, always seeking to serve others and spread the message of love, hope and salvation.
