Per the Board of Public Works new policy on honorary street signs (Resolution No. 58-2022), the approved sign may remain in place for a period not to exceed Five (5) years.

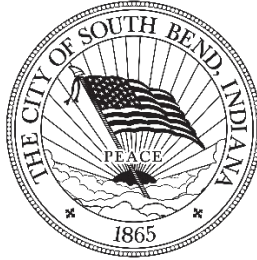

Ray's legacy includes his induction into the South Bend Hall of Fame as one of our community's humblest, most deserving "everyman" members.


The famous Portage Sunoco Service station has been known by everyone on the northwest side of town since Ray started the business in the 60s. Located on Portage Ave by the bridge, it has been a beacon for those in need of auto repair and just about everything else. It didn't matter if your bike had a flat, car needed a tune up, or you needed a new set of tires; Ray would take care of it and always end with, "Pay when you can".

He also dedicated his life to helping young people. His association with Chet Waggoner Little League is legendary. As a mentor, coach, president, groundskeeper, BP pitcher, passing out uniforms, picking up trash, and leading the yearly parade, Ray has done it all for Chet Waggoner. From the beginning days when the little league was across the street from the Manor on Portage, with 2 fields, to the present location, Ray has been the keeper of Chet Waggoner Little League.

Ray's legacy has been documented with being named as the South Bend City Council 1st District Citizen of the month, along with the St. Joseph County Citizen of the month. In addition, Ray was inducted into the South Bend Hall of Fame.

To name the intersection of Portage and Angela, along with Portage and Elwood, the "Honorary Ray Synder Ave" would be a great tribute to a man who has meant so much to the Portage Ave area.
