STAFF REPORT

The staff report was presented by Tim Staub.

Analysis: Although the neighborhood plan recommends that this parcel stay zoned as industrial, rezoning it to U3 would fulfill a goal of the Kennedy Park neighborhood plan to rehabilitate housing units in the area, as well as two related goals within the city's comprehensive plan to maintain the city's existing housing stock and support community organizations in rehabilitating older homes. Additionally, it would create continuity with the zoning of other residential parcels to the north and allow the land to be used in the same way that it has for many decades in the past.

Staff Recommendation: Based on information available prior to the public hearing, the staff recommends the Plan Commission send the rezoning petition to the Common Council with a favorable recommendation.
