A final quantity adjustment is required for the final PO request. The following items are adjusted to account for the project overrun. CLN:0010 Curb, Concrete, Remove The project plans specified the removal of 734 linear feet (LFT) of curb concrete. However, due to field conditions, the Contractor was required to remove more curb than originally anticipated. Cracking occurred in the designated cut areas, causing sections of the curb to break apart during removal. As a result, an additional 196.4 LFT of curb concrete was removed beyond the planned quantity. Please refer to the progressive report for supporting field measurements. CLN:0012 Sidewalk Concrete, Remove The contract included 2,118 square yards (SYS) of concrete removal. During removal operations, the Contractor encountered areas where additional sidewalk concrete needed to be removed to ensure proper tie-ins. Prior to the walk-through, extra sidewalk replacement was completed along Kendall St., Calvert St., and Chapin St. due to existing site conditions and the proximity to Our Lady of Hungary School. These factors resulted in an overrun of 226.14 SYS. Field measurements documenting this overrun can be found in the Site Manager templates. However, due to the need to remove additional sidewalk panels to ensure proper tie-ins, as well as the addition of sidewalk along Kendall Street, Calvert Street, and Chapin Street to address existing conditions, an overrun of 43.91 SYS occurred. However, due to the removal of additional curb necessitated by existing field conditions, as well as the installation of a return curb on Calvert Street to enhance pedestrian safety and prevent erosion of the adjacent homeowners yard, an overrun of 236.4 LFT occurred. Please refer to the progressive report for supporting field measurements. A time extension is not required for this change order. The INDOT PM has been notified accordingly.

Whereas, the Standard Specifications for this contract provides for such work to be performed, the following change is recommended. General or Standard Change Order Explanation

While developing the final plans for letting, the City of South Bend omitted sidewalk replacements at 310/726/730/808 Calvert Street. After letting, the City of South Bend requested that sidewalk replacements be added back to the Contract using a non-participating change order. INDOT and Michiana Area Council of Governments (Local MPO) approved adding the work to the Contract, Additionally, the NEPA document included the sidewalk replacements at these locations. The existing pay Item unit prices were used to establish new non-participating pay Items. The field measured quantities were used for the Item quantity. New curb ramps were installed on the northwest and southeast corners of Catalpa Street and Donald Street (Plan Sheet 17). The plans did not include new curb ramps on the northeast and southwest corners of the intersection. At the prefinal inspection, a safety concern was noted as the new curb ramps lead to curb reveals and deteriorated sidewalk. This conditions presented prefinal inspection, a safety concern was noted as the new curb ramps lead to curb reveals and deteriorated sidewalk. This conditions presented a tripping hazard and does not allow for ADA compliant access through the intersection. The Contractor was directed to add new curb ramps at the northeast and southwest corners of Catalpa Street and Donald Street. INDOT and the City of South Bend agreed to add this work using a non-participating change order. The existing pay item unit prices were used to establish new non-participating pay items. The field measured quantities were used for the item quantity. The INDOT PM has been notified accordingly. The completion dates must be revised for the additional curb ramps added at the prefinal inspection. The prefinal inspected was held on December 3, 2024. Due to temperatures, the curb ramps could not be replaced until March 24, 2025. The HMA patching at the ramps was completed once the HMA plants reopened on May 23, 2025. The intermediate completion date is revised to May 23, 2025. The Contract completion date is revised to May 23, 2025.
