**OFFICIAL CASE DISPOSITION STATEMENT**  
**Community Police Review Board - Special Meeting**

**January 15, 2026**

The Community Police Review Board (CPRB) of the City of South Bend convened for a Special Meeting on January 15, 2026, to deliberate and vote on a juvenile case presented by the Community Police Review Board following the completion of an administrative investigation and Case Summary Report.

This meeting was conducted in compliance with the Indiana Open Door Law (IC 5-14-1.5), and the deliberations and vote occurred entirely in public session.

**CASE DISPOSITION**

After receiving the Case Summary Report, reviewing the redacted investigative materials, asking clarifying questions, and engaging in public deliberation, the CPRB rendered the following vote:

- **2 Abstentions**
- **4 Votes to Disagree with The CPRB Findings**
- **1 Vote to Agree with The CPRB Findings**

Consistent with Ordinance 10721-20, the CPRB's role in this matter is limited to determining, based solely on the evidence provided, whether the policies of the South Bend Police Department were followed.

The vote recorded above reflects the Board's independent civilian review of the findings presented.

2. The CPRB's vote constitutes a civilian oversight finding, not a disciplinary decision. All disciplinary authority remains with the Police Chief and the Board of Public Safety, in accordance with Indiana law.
3. Any policy recommendations arising from the Board's deliberation will be documented separately and transmitted to the appropriate city entities.
