Attached, please find the Project Narrative kept by Amereco Inc. and photographic documentation in association with the removal of one (1) underground storage tanks (USTs). Amereco provided oversight during the removal of the UST on January 25, 2012.

- 8:00 AM Amereco arrives onsite. The UST located adjacent to the project trailer, near the West side of the project site. UST 14 has been previously uncovered but will require limited soil excavating to remove. UST 14 is a 1,200 gallon UST, which was free of liquid and sludge.
- 8:30 AM Dore begins uncover UST 14 for removal. The local fire department inspector was contacted, out of courtesy. Local fire department give its ok to proceed and will not be attending the removal.
- 9:00 AM UST 14 is uncovered and removed from ground. UST is transported to impermeable surface, located near UST removal location, for staging, cleaning and removal from site for destruction. UST 14 has significant holes and has been rendered unusable.
- 9:30 AM No further action is necessary by Amereco. UST 14 has been safely removed from excavation and poses no risk to human health and safety. Dore to further destroy and transport for disposal on later date. Amereco offsite.
