

**NOW, THEREFORE, BE IT RESOLVED** by the South Bend Redevelopment Authority as follows:


1. The Authority approves and adopts as its regular meeting schedule for calendar year 2016, the meeting dates and times more specifically described at *Exhibit A* attached hereto.
