Clerk Tirado read the bill to the Council for its second (2nd) reading.

After the second (2nd) reading, Councilmember Dr. Davis stated that Bill *No.* <u>31-25</u> went before the Zoning and Annexation Committee and comes with no recommendation.

Tim Staub, Zoning Specialist, with offices on the fourteenth (14th) floor of the County-City Building, South Bend, IN 46601, stated that Bill *No.* 31-25 requests to amend the zoning ordinance for property located at 314 West Chippewa Avenue from Commercial (C) to Suburban Neighborhood 2 (S2). The site is currently a vacant lot, and the proposal is consistent with the South Bend Comprehensive Plan. The petitioner is Birge and Held (B&H), and they seek to construct a three-story (3) apartment with a common space and parking lot.

Sam Rogers, Senior Vice President of Development, B&H, 8902 North Meridian Street, Suite 205, Indianapolis, IN 46260, stated that B&H requests the re-zoning to develop workforce housing consisting of one hundred and eight (108) units within five (5) buildings. This development would mostly be two (2) and three (3) bedroom units with costs ranging between nine hundred dollars (\$900) and thirteen hundred dollars (\$1300). Sam Rogers stated that the tenants would pay one (1) cost for rent with all utilities built into the fixed price of the unit.

Councilmember Gooden-Rodgers asked if there is a scrap metal shop nearby, how far away are they, and is noise a concern.

Sam Rogers stated that the scrap metal shop is nearby but does not present any environmental or noise concerns.

Councilmember Bolden-Simpson expressed excitement for more housing in the Fifth (5th) District and asked how the children will be accommodated.

Sam Rogers stated that the property will have a park, pool, fitness center, play area, and gazebo.

Council Vice President Rachel Tomas Morgan asked Sam Rogers to share his experience with development in Indiana, South Bend, or the surrounding region.

Sam Rogers stated that B&H have developed around three thousand (3000) units in the state of Indiana, all of which are affordable in nature, and that this unit is the first in South Bend.

President Lee expressed his thanks and spoke on behalf of a concerned citizen asking how B&H will prevent the unit from turning into a slum.

Sam Rogers stated that the construction type is high end and B&H have operating costs in place to assist with maintaining the property along with programs in place that enforce residents to provide proof of income and employment status.

Councilmember Niezgodski asked who will be maintaining the property and overseeing the facility and will they be local.

Sam Rogers stated that B&H will manage the property and will have staff with twenty-four seven (24/7) maintenance on site.

Councilmember Niezgodski asked if water and gas will be included in the rent

Sam Rogers stated that water and Wi-Fi will be included in the rent and that the property will be all electric.

Councilmember Gooden-Rodgers asked if B&H will supply their own crew or use local or union workers

Sam Rogers stated that B&H has their own construction company but will bid out locally.

Councilmember Bolden-Simpson asked if Sam Rogers would elaborate on the solar energy component.

Sam Rogers stated that there will be solar panels on the rooftop and on top of the carports.

Councilmember Warner held the public hearing, and nobody spoke.

Councilmember Sharon McBride recognized that the boy scouts were in attendance and that a young boy scout approves of Bill No. 31-25.

Councilmember Bolden-Simpson moved to send Bill *No.* <u>31-25</u> to the Full Council with a favorable recommendation, which was seconded by Councilmember Niezgodski and carried by a vote of nine (9) ayes.

Councilmember Dr. Davis moved to accept Substitute Bill *No. 32-25*, which was seconded by Councilmember Bolden-Simpson and carried via a vote by voice.

Clerk Tirado read the bill to the Council for its second (2nd) reading.

After the second (2nd) reading, Councilmember Dr. Davis stated that Substitute Bill *No.* <u>32-25</u> went before the Zoning and Annexation Committee and comes with a favorable recommendation.

Councilmember Warner requested that the petitioner(s) state their name and address and share key points before the council.

Tim Staub, Zoning Specialist, with offices on the fourteenth (14th) floor of the County-City Building, South Bend, IN 46601, stated that Substitute Bill *No.* 32-25 requests to rezone a vacant property located at 1037 Colfax Avenue from Urban Neighborhood One (U1) to Urban Neighborhood Flex (UF). The petitioner is Miatt Properties LLC, and they seek to convert the existing vacant home into office space. Originally the staff had recommended unfavorable due to the petition not meeting the city plan to ensure adequate supply of housing. When the petition was brought before the Plan Commission, the petition was found to have a low impact on the neighborhood and the petition was found favorable with written commitments restricting the lots development potential.

Myra Reid, Miatt Properties LLC, 1822 East Fox Street, South Bend, IN 46613, stated that Miatt Properties LLC requests to rezone a vacant property located at 1037 Colfax Avenue from Urban Neighborhood One (U1) to Urban Neighborhood Flex (UF). This property has been vacant for four (4) years and has been occupied by unauthorized people, people without housing, and wild animals who have damaged the property. Myra Reid seeks to convert the existing vacant home into office space. Myra Reid stated that the property will remain the same, ensuring that the property will be maintained and the business signage will be sophisticated.

Councilmember Dr. Davis asked about the neighbors Myra Reid spoke with, their feedback, and Myra's thoughts. Councilmember Dr. Davis asked if Myra Reid had encountered any neighbors in opposition and how were their concerns addressed. Councilmember Dr. Davis asked if Myra Reid had any issues abiding by the twenty-three (23) commitments.

Myra Reid stated that she spoke with the direct neighbors, in front, behind, and next to the property. The consensus was that the neighbors were happy to know the property would be well maintained. Myra Reid stated that she did not meet any neighbors in opposition, but one neighbor expressed concern about the property turning into a residential rental. Myra Reid stated that she has no issues with abiding by the commitments.

Council President Lee asked how much the petitioner will have to invest in the property before it is functional.

Myra Reid stated that it would be a lot and did not provide an exact number.

Councilmember Bolden-Simpson asked if the property is handicap accessible.

Myra Reid stated that there is a ramp in the back and repairs are needed.

Councilmember McBride asked Councilmember White and Councilmember Dr. Davis if they had ever seen twenty-three (23) commitments before.

Councilmember White and Councilmember Dr. Davis answered no.

A conversation ensued between Councilmembers regarding the number of commitments.

Councilmember Niezgodski thanked the petitioner for their investment.

Council Vice President Tomas Morgan thanked the staff for their time and effort. Council Vice President Tomas Morgan recommended that all commitments be written down moving forward. Council Vice President Tomas Morgan asked the staff if the petition goes back to the Plan Commission to modify or terminate, would the petition come back to the Council. Council Vice President Tomas Morgan asked if Tim Staub would show a specific slide to identify the zoning.

Tim Staub stated that the petition would not return to the Council but would need to have a public hearing before the Plan Commission. Tim Staub showed a specific slide.

Council Vice President Tomas Morgan asked the petitioner if the offices would be lived in on the property.

Myra Reid stated that no one would be living on the property.

Councilmember Gooden-Rodgers thanked the petitioner for their investment.

Councilmember Warner opened the public hearing.

Alice Marie Pickens, 234 North Albert Avenue, South Bend, IN 46619, expressed her excitement for Substitute Bill *No.* 32-25.

Councilmember Warner closed the public hearing.

After the second (2nd) reading, Councilmember Dr. Davis stated that Bill *No.* <u>40-25</u> went before the Zoning and Annexation Committee and comes with no recommendation.

After the second (2nd) reading, Councilmember Warner requested that the petitioner(s) state their name and address and share key points before the council.

Tim Staub, Zoning Specialist, with offices on the fourteenth (14th) floor of the County-City Building, South Bend, IN 46601, stated that Bill *No.* 40-25 requests a special exception for property located at 1527 South Michigan Street for the use of Vehicle Service, Minor. The site was previously occupied by an automobile dealership. Staff recommended unfavorable due to the proposed use not being compatible with the recommendations of the 2015 Southeast Neighborhood Plan which called for dense commercial use at the Michigan and Indiana intersection. The Board of Zoning Appeals reviewed the staff's recommendation and found the site was developed for Vehicle Service, Minor and the special exception was warranted and a favorable recommendation was provided.

Fares Farhan, Tea Rose Lane, Mishawaka, IN 46544, stated that his family has been maintaining and repairing the property located at 1527 South Michigan Street and requests a special exception for the use of Vehicle Service, Minor.

Council President Lee asked if the previous owner informed Fares Farhan of the zoning change and what would make the shop different from others.

Fares Farhan stated that he was not informed of the zoning change and wants to have a tenant that works closely with the surrounding community.

Councilmember Bolden-Simpson expressed her concerns about adding another automobile shop.

Fares Farhand stated that he would not be adding a car dealership.

Councilmember McBride thanked Councilmember Bolden-Simpson for her comments and expressed her concerns about adding another automobile shop.

Councilmember Warner held the public hearing, and nobody spoke.

Councilmember Dr. Davis asked as this property will now be left vacant, what type of commitments could be established with respect to beautification or impovements of this parcel of property?

Councilmember McBride agreed with Councilmember Dr. Davis and stated that as the property stands she cannot support a favorable recommendation.

Councilmember Bolden-Simpson recommended reaching out to Erik Glavich in Community Investment for recommendations on what else could be established.

Councilmember Gooden-Rodgers asked the petitioner if Council could table Bill No. 40-25.

Fares Farhan stated that would be okay.

Councilmember McBride and Councilmember Dr. Davis stated that a meeting should be held with the petioner.

The property was previously used for a Catholic School and Day Care and is fitting for the existing structure and is consistent with the Near West Side Neighborhood Plan.

Joshua Caneff, Director of Admissions at Trinity School at Greenlawn, 1024 Thomas Street, South Bend, IN 46601, stated that Trinity School is grateful for this new chapter and is looking forward to moving into the near West Side neighborhood.

Councilmember White thanked the petitioner and asked how many classes Trinity School would offer.

Joshua Caneff stated that Trinity School would provide education from grade six (6) through twelve (12).

Councilmember Gooden-Rodgers asked what will be different about Trinity School, will it be prepared for disadvantaged students and have affordable tuition.

Joshua Caneff stated that Trinity School has a long history of providing education in the area and experience offering education to students from families with extra needs. Joshua Caneff stated there is tuition with internal financial aid available and Trinity School accepts vouchers from the state of Indiana.

Councilmember Bolden-Simpson asked if Trinity School will accept Title One (1) students and how will they (or Trinity School) work with the South Bend School Corporation to provide services for students with disabilities.

Joshua Caneff stated that Trinity School has partnered with local South Bend schools to accommodate students with disabilities because they do not offer a curriculum that caters to students with disabilities.

Councilmember Warner held the public hearing, and nobody spoke.

Councilmember Bolden-Simpson expressed concerns about families with cognitively disabled children and the lack of educational choices. Councilmember Bolden-Simpson recommended that Trinity school expand their services.

Council Vice President Tomas Morgan thanked the petitioner for their presentation and complying with the Near West Side Neighborhood Plan.
