Committee Chair Sheila Niezgodski called to order the Public Works and Property Vacation Committee meeting at 5:40 P.M.

Bill No. 64-24 - Alley Vacation - 512 South Walnut Street

Committee Chair Niezgodski stated that Bill *No.* <u>64-24</u> was tabled <u>December 9, 2024</u>, due to the alley vacation denying access to the residents own property.

Gemma Stanton, Project Engineer, with offices on the thirteenth (13th) floor of the County-City Building, South Bend, IN 46601, stated that they were unsure that the alley vacation would alleviate the problems the resident is experiencing but they would still be able to walk the resident through the process if they are still interested.
