Committee Chair Troy Warner called to order the Community Investment Committee meeting at 6:03 P.M.

Bill No. 25-36 - Confirming Resolution - Real Property Tax Abatement for KCG Companies, LLC

Erik Glavich, Director of Growth and Opportunity, with offices on the 14th floor of the County-City Building, South Bend, IN 46601, stated that Bill *No.* <u>25-36</u> is a ten-year (10) real property tax abatement for property located at 2020 South Main Street, South Bend, IN 46613. The plan would bring fifty (50) new affordable apartment units. The property's pre-project estimated annual taxes are two hundred and sixty-nine dollars (\$269), whereas after the project, the estimated annual taxes are forty-one thousand and fifty-two dollars (\$41,052).
