Erik Glavich, Director of Growth and Opportunity, with offices on the fifth (5th) floor of City Hall, South Bend, IN 46601, gave a PowerPoint presentation about VERBIO's investment in the ethanol plant. He said the tax abatement designation period is set to expire before the necessary federal approvals are granted.

Greg Northrup, President and Chief Executive Officer (CEO) of VERBIO North America, Grand Rapids, MI, spoke about VERBIO's plan to produce renewable natural gas at the facility. He elaborated on the federal approval process and the reasons for the delay. He said VERBIO has already invested twenty-million dollars (\$20,000,0000) in new equipment and infrastructure, and they have increased their workforce from sixty-one (61) to eighty (80) employees.

Councilmember Dr. Davis spoke about how the ethanol plant's closure affected the community and expressed support for the project.

Councilmember Niezgodski asked about the reason for choosing this location.

Greg Northrup said they were looking to purchase an ethanol plant at a reasonable price in an area with the required resources and infrastructure. He said they have a biorefinery in Iowa with a similar production process.

Council President Lee held a joint public hearing, and nobody spoke.

Councilmember White voiced her support for the project.

Council Vice President Tomas Morgan said the Council has been excited about the project since <u>2023</u> and disappointed by the federal delays.

Greg Northrup spoke about the importance of renewable energy and its challenges as an emerging industry.

Councilmember Niezgodski said the sixth (6th) district supports the project and she is impressed with the progress despite the delays.
